CIRCULAR

The Divisional Accountants (Probationers) who were declared successful in the Divisional Accountant Grade Examination, March 2024, vide this office's Office Order No. 8 dated 24/04/2024 are directed to submit their option for **Region viz., Nagpur region or Mumbai region**. It may be noted that conditional option will not be considered.

Further, it may also be noted that in terms of the parameters contained in transfers and postings guidelines dated 20/03/2015 issued by the Headquarters' office, in case of overall vacancies, the same should be evenly distributed across the State as far as possible and posting of the officials should be made in the appropriately graded Divisions as far as possible. Therefore, Region shall be allotted as per vacancy position in Mumbai and Nagpur region and considering administrative exigencies. Also, while submitting the option for region, it may be kept in mind that the passed candidates of 2019 and 2020 batch will be proportionately distributed between Nagpur and Mumbai Regions.

The option should be addressed to "Sr. Deputy Accountant General (Works Accounts)", super-scribed as "CONFIDENTIAL --OPTION FOR POSTING OF A REGION" on the envelope, and submitted in a sealed envelope to the P.A. to the Sr. Deputy Accountant General (Works Accounts) by 4.00 PM 01/05/2024. In case of non-receipt of option by the due date, posting will be decided as per the availability of vacancy.
