CIRCULAR-44

Divisional Accountants (Probationers) who have qualified the Divisional Accountants Grade Examination, September-2024 and allotted Mumbai Region are hereby directed to submit their options in the order of preference, for all stations for appropriately graded vacant divisions from the given list of vacant divisions. On confirmation in service, regular charge will be given in accordance with the Headquarters guidelines dated 16.08.2024. It may be noted that option received for only one station will not be considered. Any conditional option including option for a place with a particular division will not be considered. It is likely that the Division appropriate to their grade may not be available to accommodate them in the same station. In that case, they may be shifted outside the station nearby his/her option.

They may also note that their posting to the station opted by them will be considered subject to availability of vacancy and in terms of Headquarters guidelines dated 16/08/2024, administrative exigencies and geographical/district-wise distribution of vacancies.
