CIRCULAR-69

The Divisional Accountants Grade Examination for the Divisional Accountant (Prob.) will be held in this office with effect from **17/09/2025 to 20/09/2025**. The eligibility etc., is as under:

1. Divisional Accountant (Probationer) recruited through Staff Selection Commission and has completed one year of practical training.
2. It is obligatory for the eligible Divisional Accountant (Probationer) to pass the Divisional Accountant Grade Examination during the period of probation.
3. The maximum number of chances admissible are **three (3)**.
4. All the eligible candidates are required to appear in the examination compulsorily and this examination will be counted as one of the chances for the purpose of counting of maximum **three** numbers of chances admissible.
5. The Principal Accountant General may, at her discretion, permit in deserving cases, relaxation of the prescribed conditions relating to number of chances, length of service, training etc., as per orders on the subject.
6. In terms of the Headquarters' Circular No. 04 of 2023, issued vide letter No. 431/05-Exam/DAGE Syllabus Revision/2022 dated 09/10/2023, there are 7 papers in the **revised syllabus** of DAGE. Total marks in each paper are **100**, and pass/exemption marks in each paper is **45**. Negative marks for each wrong answer of MCC are 0.25. No negative mark for conventional and practical paper/part. IT practical paper will be conducted on computer.
7. The revised syllabus for the examination is enclosed. The candidates have to note that they have to appear for all the papers mentioned in the aforesaid letter except the paper wherein they have secured exemption in the earlier examination.
8. The application for the Divisional Accountants Grade Examination in the prescribed format should be submitted in the enclosed format giving the required details. Application forms containing incomplete or incorrect information will not be considered.

9. All the question papers will be in English.
10. Time table and venue of examination will be communicated separately.
11. **Last date of receipt of application is 08/09/2025.** Applications received after the above date will not be considered under any circumstances.
