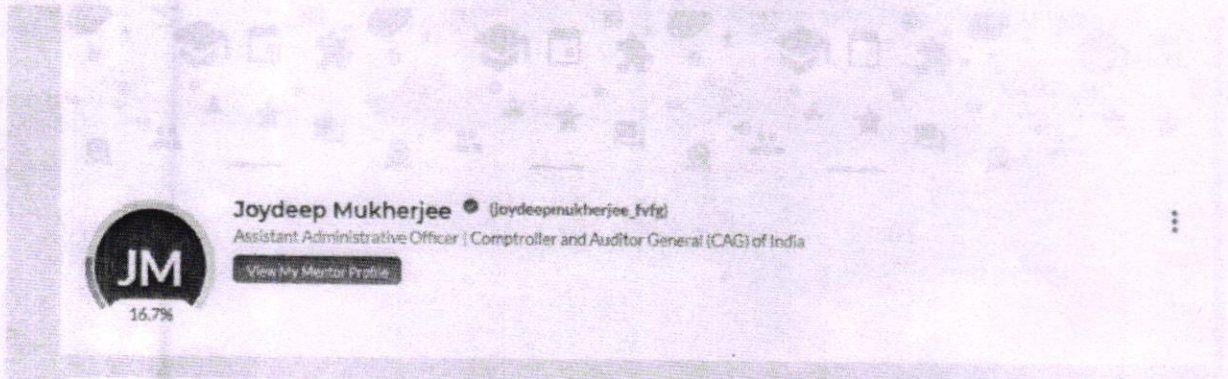
Unable to login:

Select your designation and group, then click on "submit request" button.
