Consequent upon the transfer of Ms. Inabat Khaliq (DAG) and concurrence regarding the nomination of a new Chairperson of the Internal Complaints Committee (ICC) by the Government of Jammu and Kashmir, the Competent Authority has been pleased to **reconstitute** the ICC for redressal of complaints, if any, of sexual harassment of women employees working in the office of the Principal Accountant General (Audit), Jammu & Kashmir, at both stations viz. Srinagar and Jammu.

This reconstitution is made in terms of Notification No. 11013/10/97-Estt.(A) dated 13.02.1998 issued by the Government of India, Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training), and in pursuance of the provisions contained in Section 4 of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013.

Further, while dealing with complaints, if any, the Committee shall ensure that the victims or witnesses are not subjected to victimisation or discrimination during the inquiry process. The provisions contained in Office Memorandum No. F.11013/2/2014-Estt.(A-III) dated 16.07.2015 issued by the Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training, shall be kept in view while handling such complaints.

The tenure of the Chairperson and Members of the ICC shall be for a period of three years from the date of issue of this order.
