### **Constitution Of Data Analytics Cell (DAC)**

With a view to operationalising the directions issued during the Hon'ble CAG's visit— particularly in the areas of data-led scrutiny, integrated database analysis, digitisation, and Audit–A&E synergy and to institutionalise analytics-based working within this office, the Principal Accountant General (A&E), Manipur hereby constitutes a Data Analytics Cell (DAC) with immediate effect. The following Officers are designated as members of the newly constituted Data Analytics Cell until further orders.

The Data Analytics Cell (DAC) shall, *inter alia*, perform the following functions:

- Undertake data-driven scrutiny of financial transactions, including salary, pension, GE and GPF records, using appropriate analytical tools and techniques.
- Carry out integrated database analysis by consolidating data from VLC, GEMS, PFMS, IFMS, and other relevant systems.
- Support digitisation initiatives and coordinate with the Audit Office to strengthen synergy between Treasury Inspection and Audit (A&E).
- Institutionalise analytics-based processes and promote optimal utilisation of existing financial data within the Accounts Office.
- Perform any other functions as may be assigned by the Competent Authority from time to time.
- Coordination with the DAC of local Audit Office for facilitating data-sharing as and when required.
- The DAC shall report to the Senior Deputy Accountant General (A&E),

Manipur, and shall submit periodic progress reports as directed.

This order is issued with the approval of the Principal Accountant General (A&E), Manipur, vide Note #3 dated 27.05.2026 in e-File No. PAG/AE/MNP/DA-Pol/26-27, and shall take effect from the date of issue.
