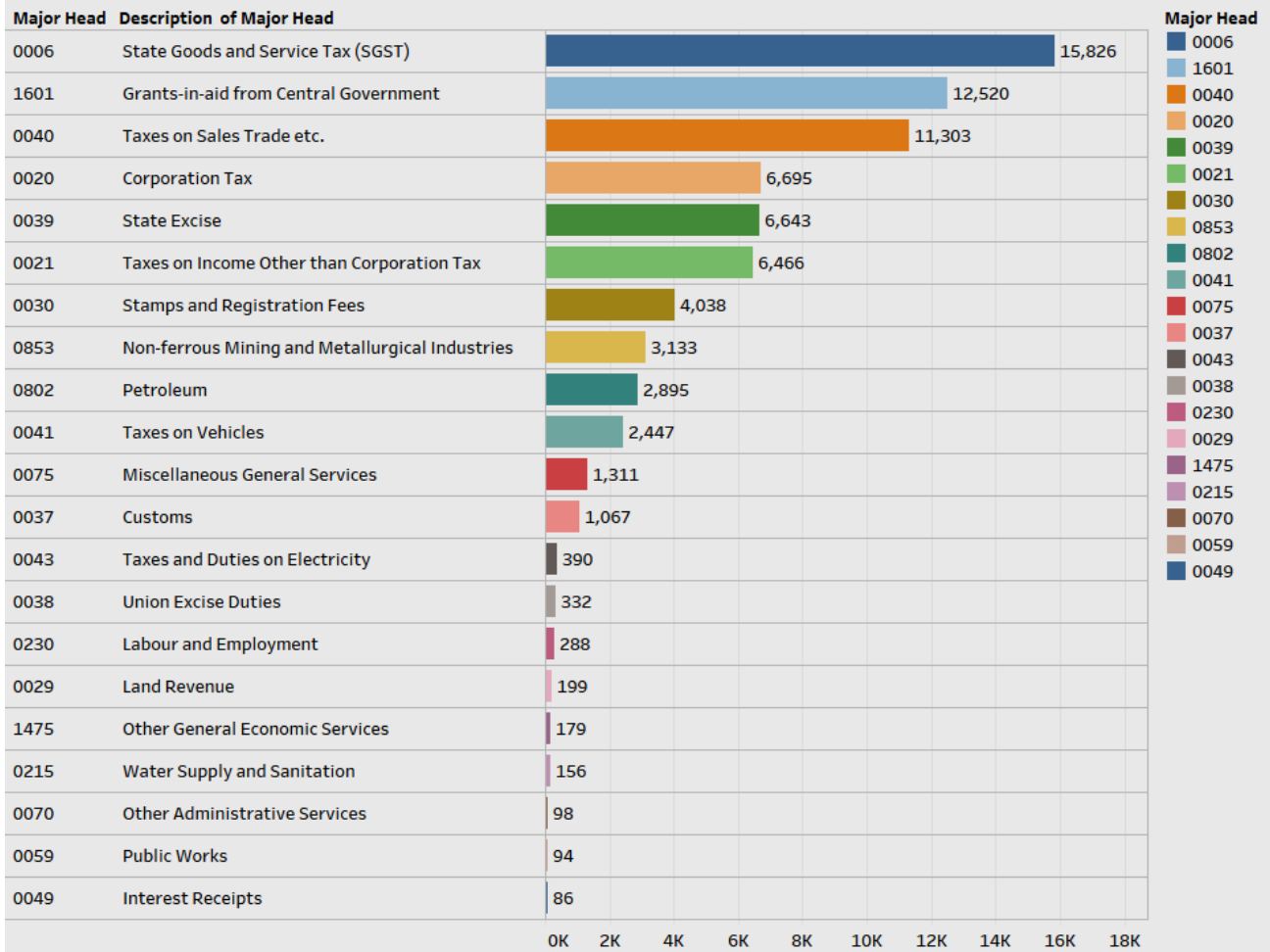

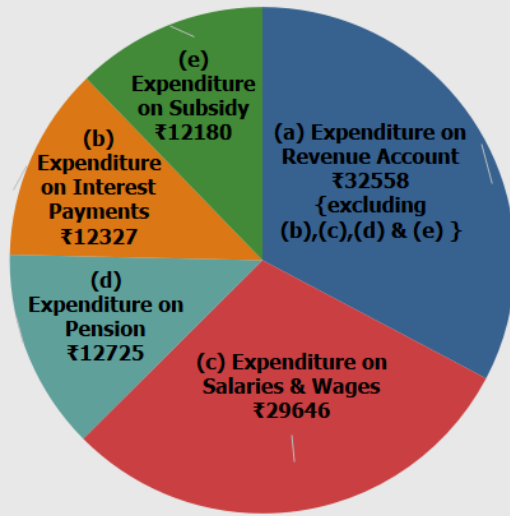
Tax Revenue upto 09/2022

Major Head Wise Revenue Receipts upto 09/2022 (Amount in Crore)

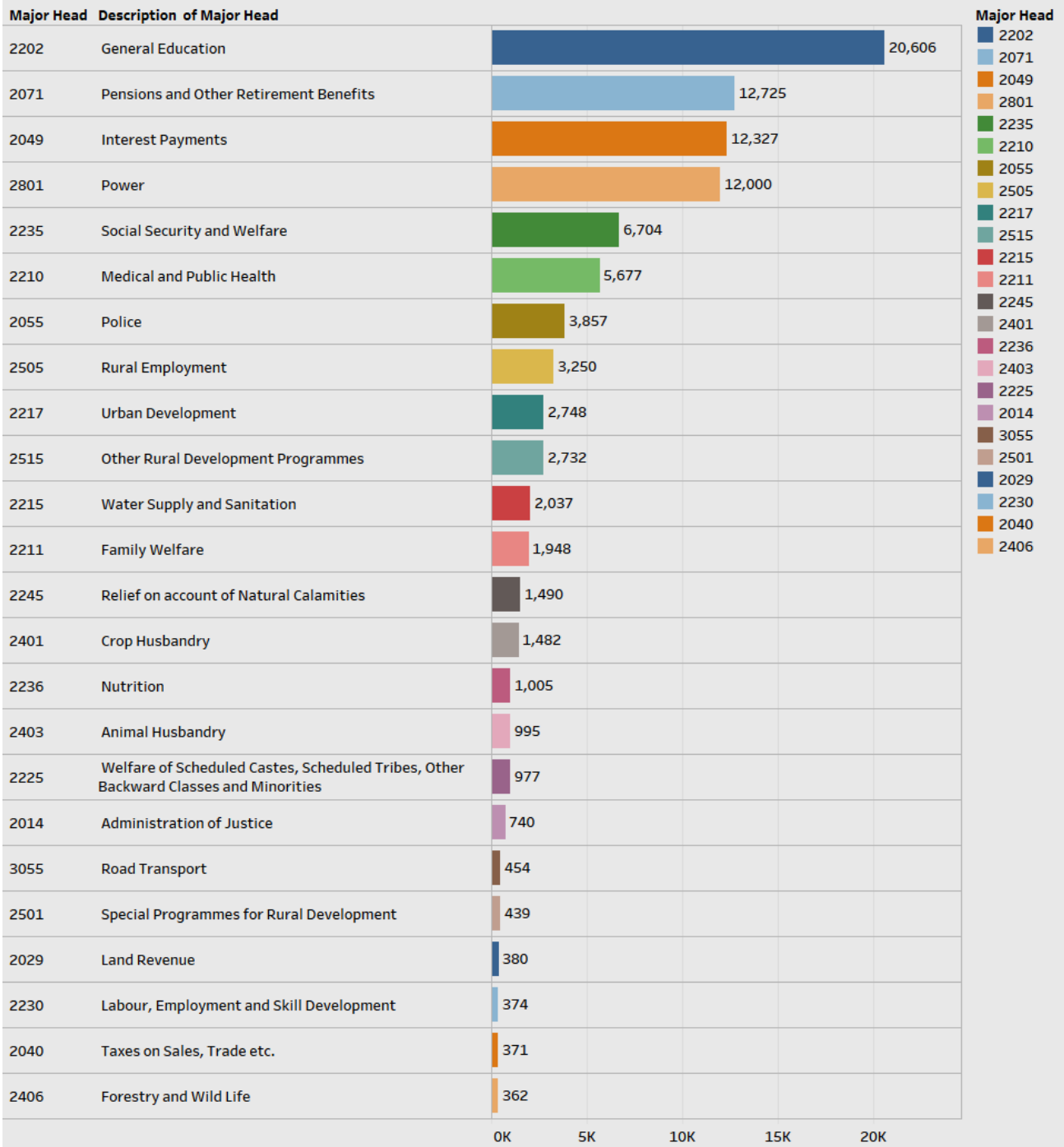


Revenue Expenditure upto 09/2022  
(Amount in Crore)



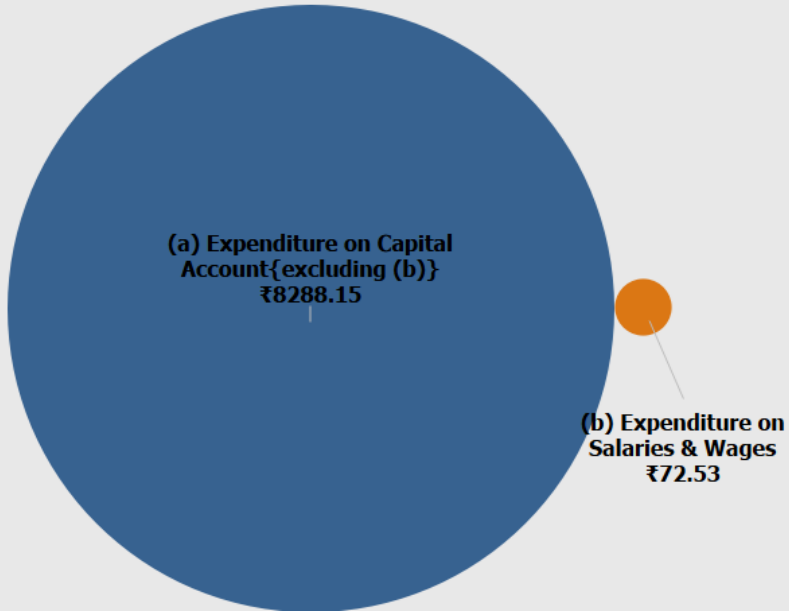

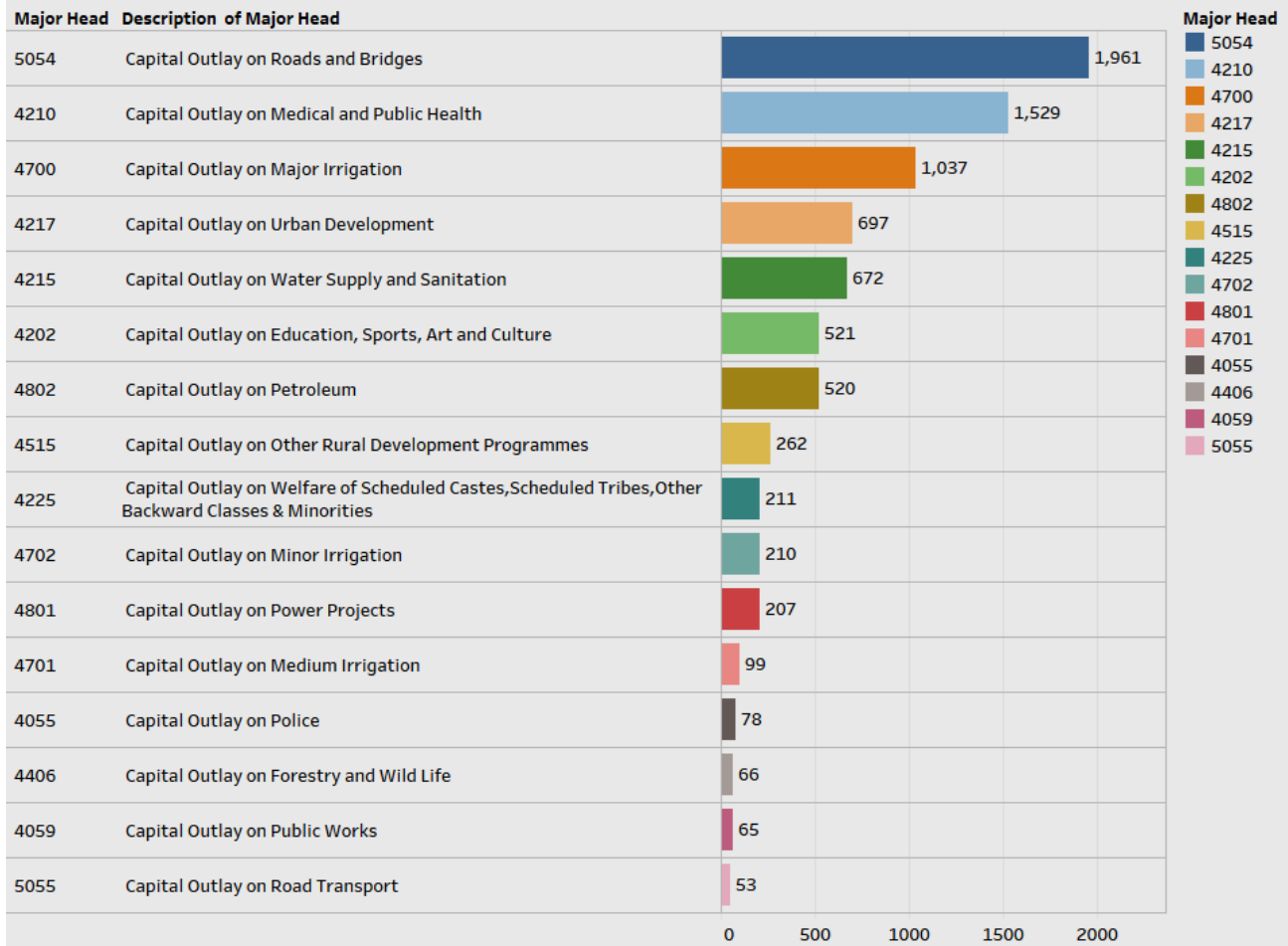


Capital Expenditure upto 09/2022

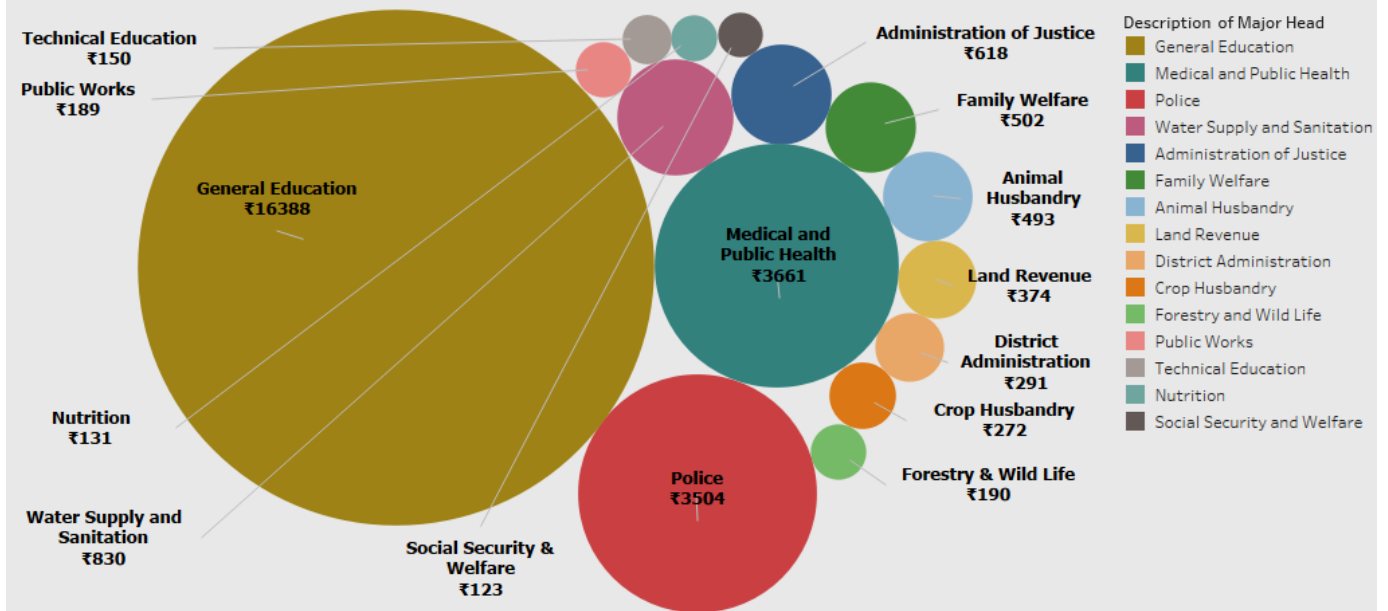
Capital Expenditure

Major Head Wise Capital Expenditure upto 09/2022 (Amount in Crore)

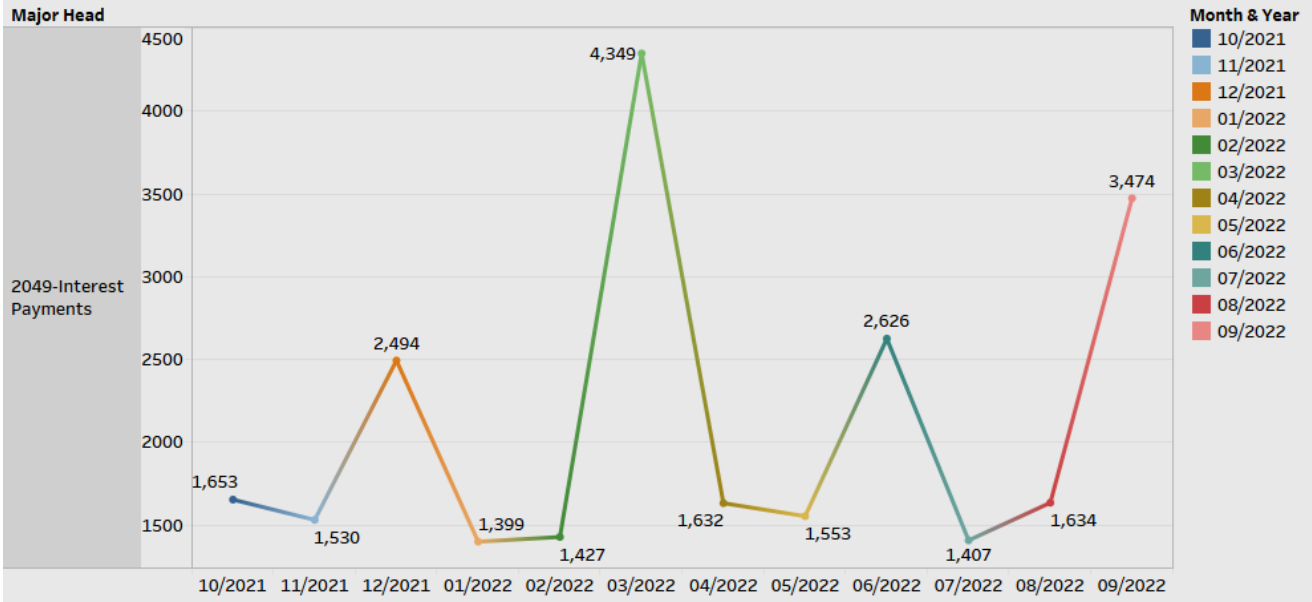


Position of Department wise Salary upto 09/2022

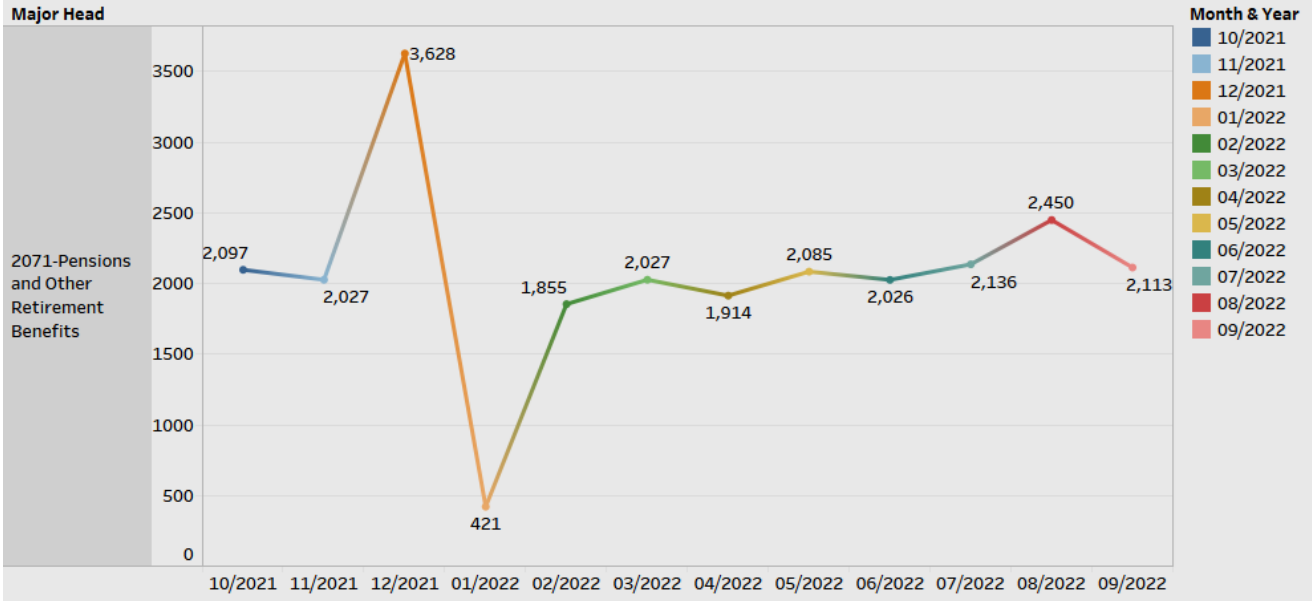




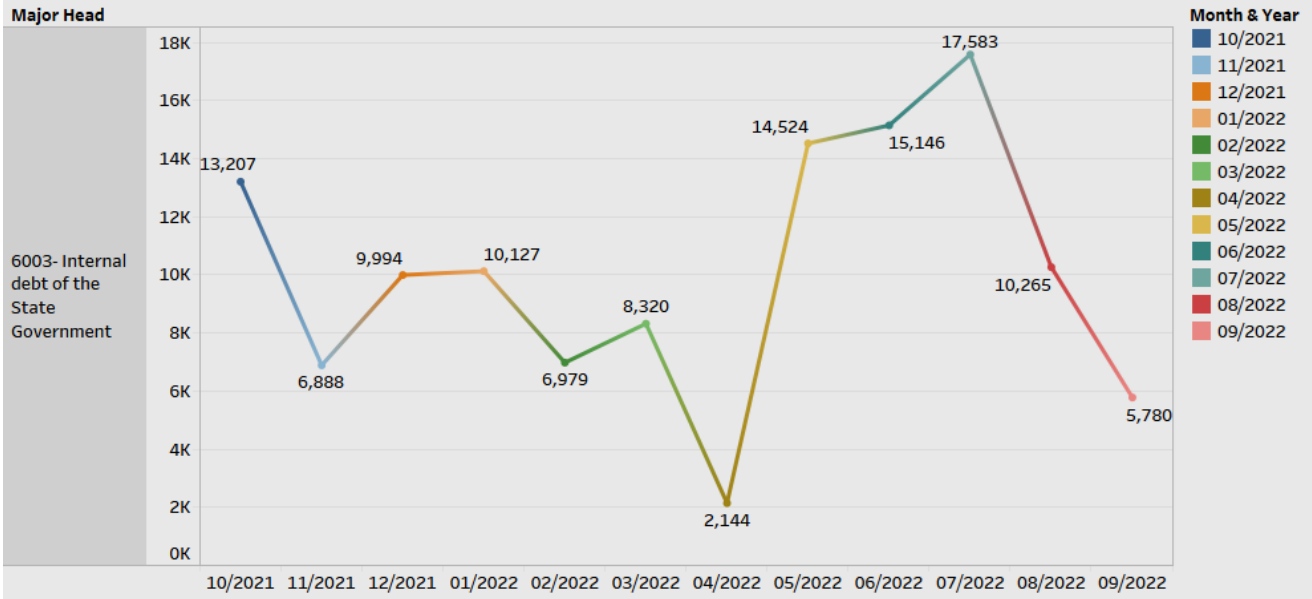
Monthly Trends of Expenditure on Interest Payments

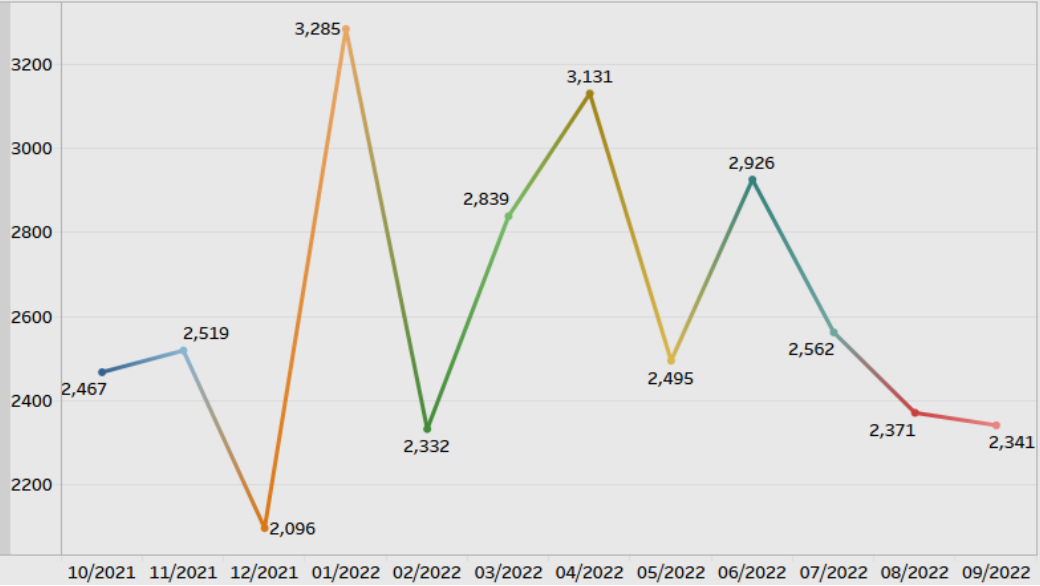

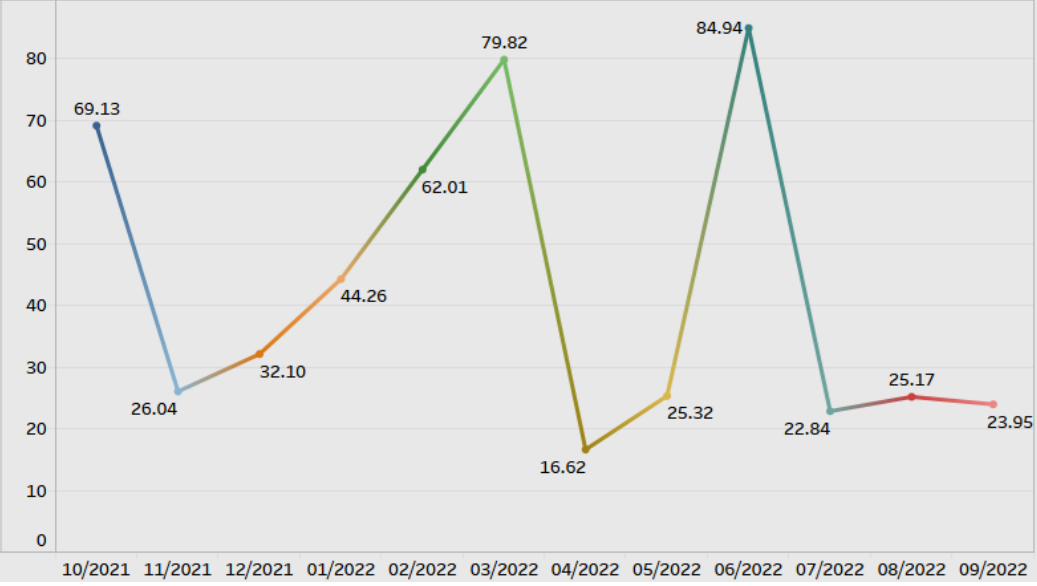

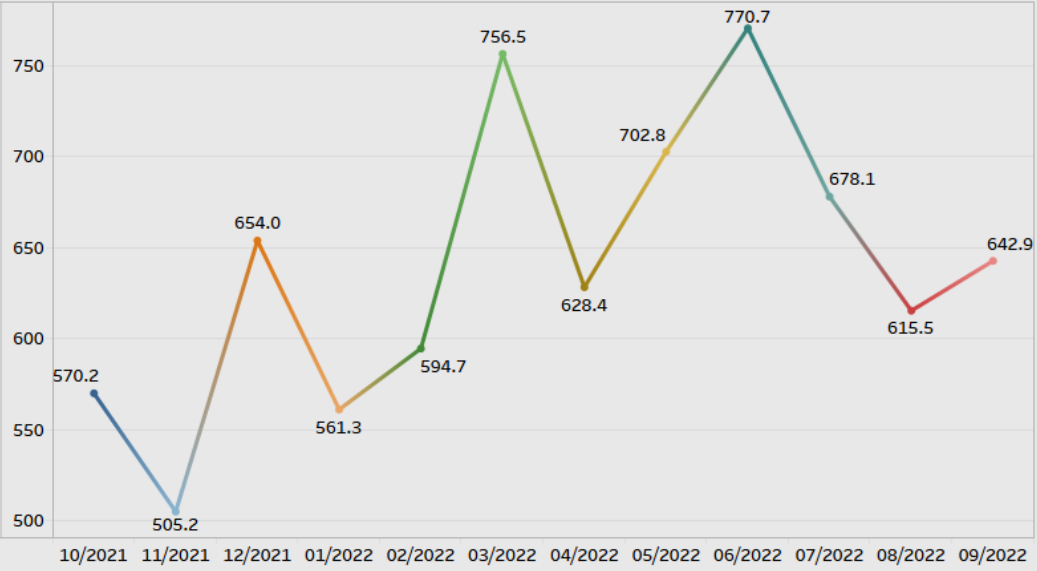

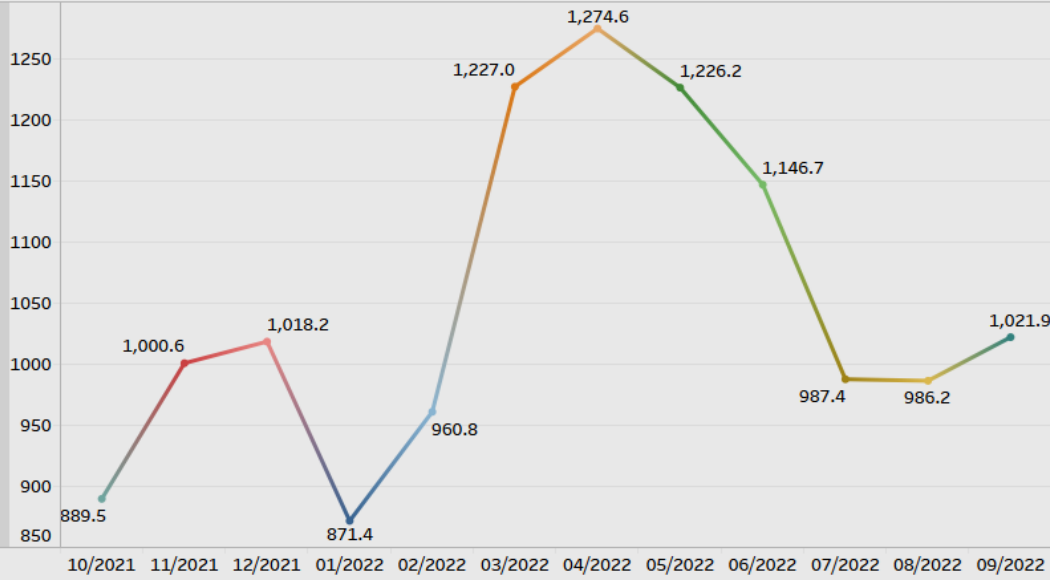

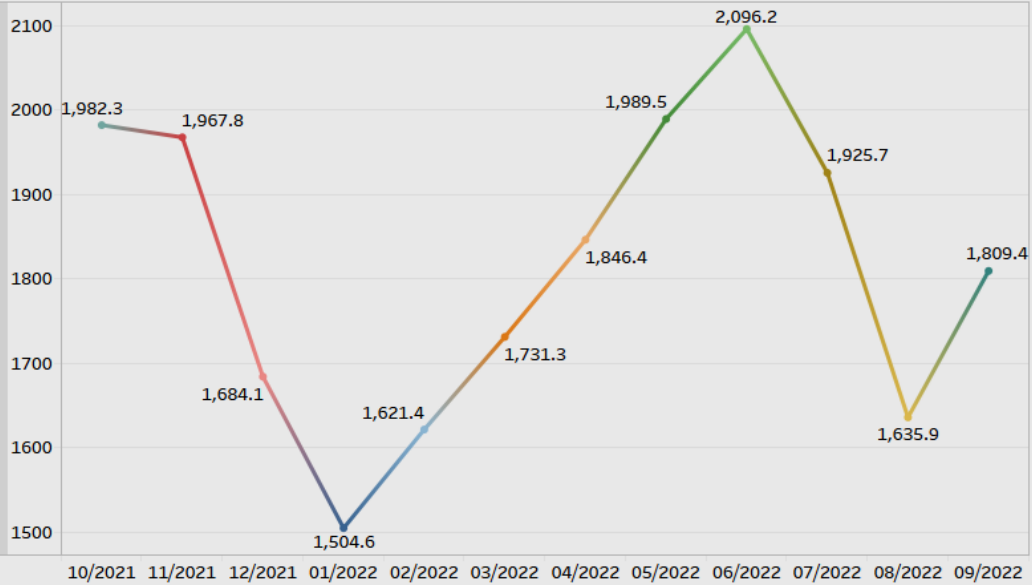

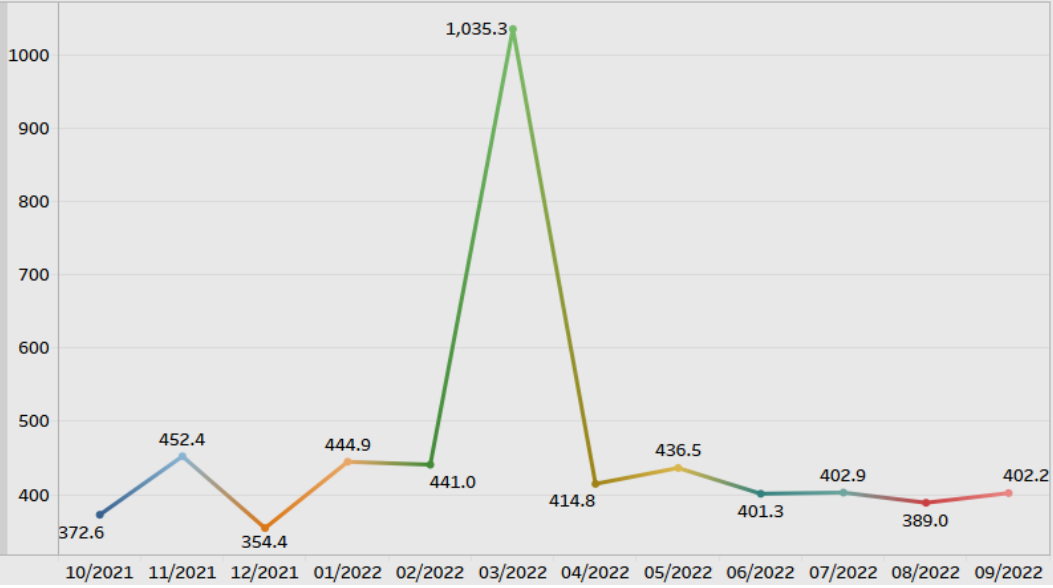

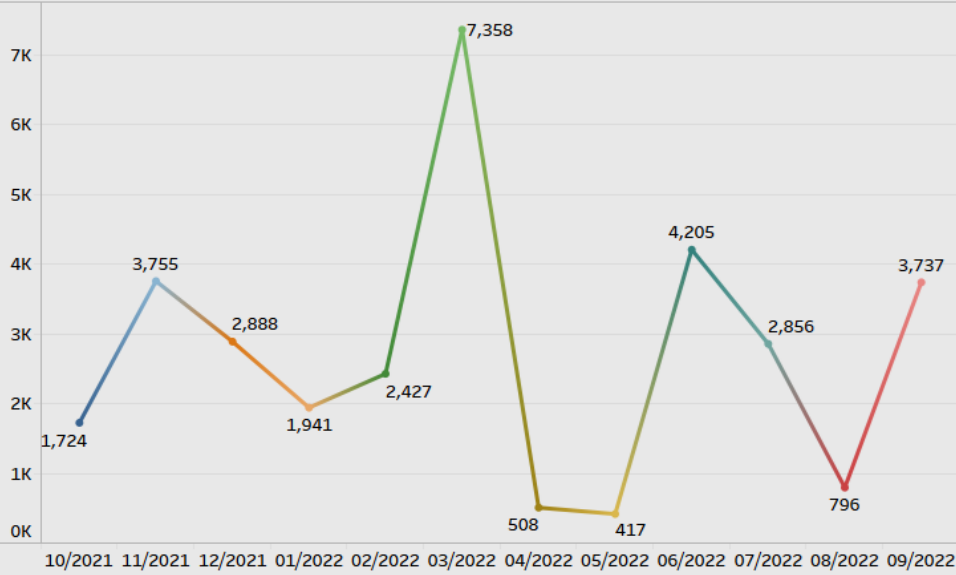

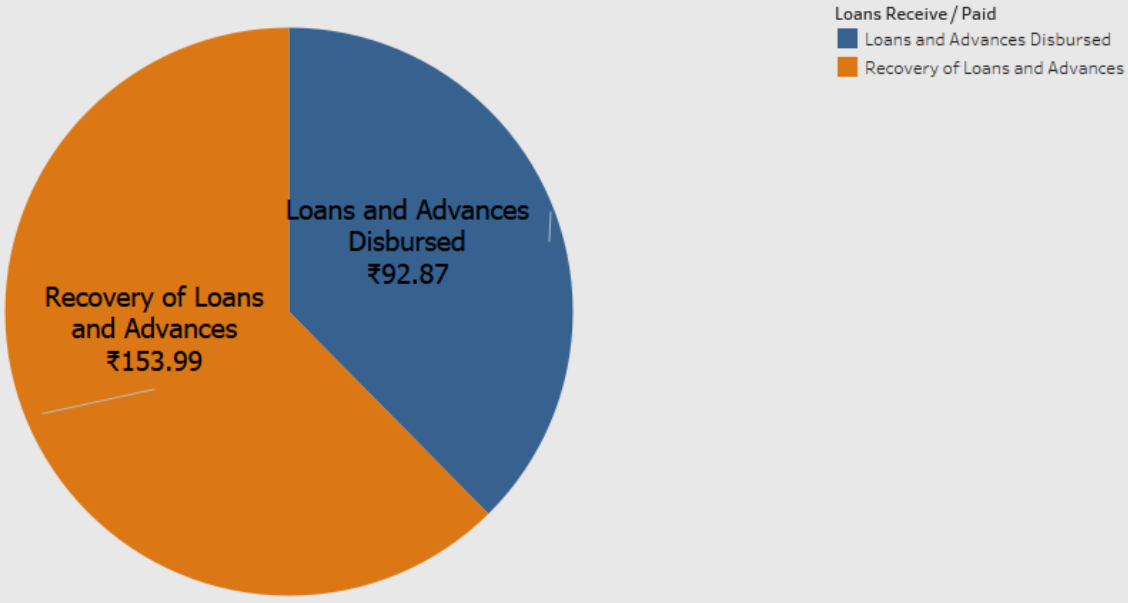

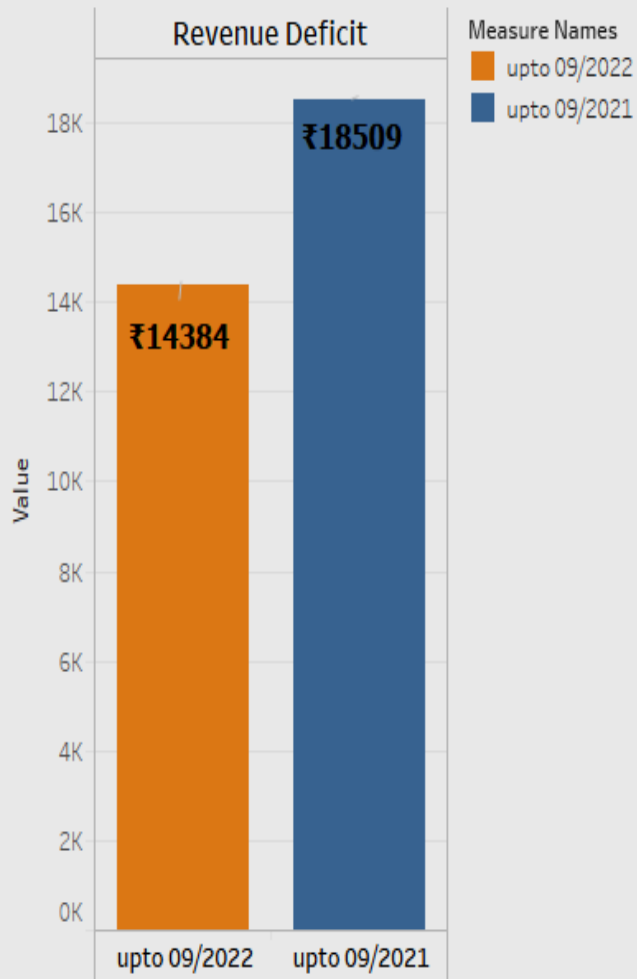
