Subject:- Grant of revised rate of Dearness Relief @ 53% to Central Government Pensioners / Family Pensioners etc. effective from 01/07/2024

In continuation to this office circular No. Pen. Co-ordn.755 Vol.VII/142 Vol.III/65 Vol-IV/66 Vol.III/205 dated 14/03/2024, it is stated that Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Pension & Pensioners' Welfare under their O.M. No 42/02/2024-P&PW(D) dated 30/10/2024 have sanctioned Dearness Relief at the rate of 53% with effect from 01/07/2024 in supersession of the rate mentioned in O.M. No 42/02/2024-P&PW(D) dated 13/03/2024 to (i) Civilian Central Government pensioners/family pensioners including absorbee pensioners in PSU/Autonomous Bodies (ii) The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates, (iii) All India Service Pensioners / family pensioners (iv) Railway Pensioners / family pensioners (v) Pensioners who are in receipt of provisional pension (vi) The Burma Civilian Pensioners / Family Pensioners and (vii) Pensioners/families of displaced Government pensioners from Pakistan.

2. This circular will not be applicable to

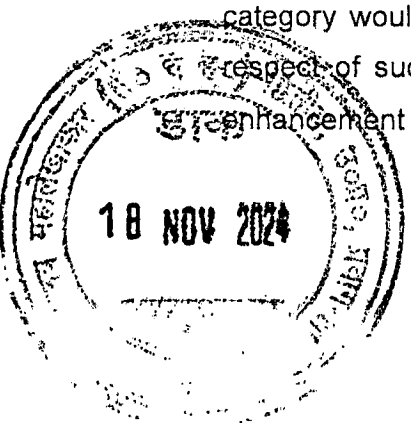
(a) CPF beneficiaries, their widows and eligible children who are in receipt of ex-gratia payment in terms of Department of Pension & Pensioners' Welfare OM No. 45/52/97-P&PW(E) dated 16/12/1997 and revised subsequently vide OM No. 1/10/2012-P&PW(E) dated 27/06/2013.

(b) Burma Military pensioners / family pensioners.

3. The retired officers of West Bengal Judicial Service and family pensioners of such category would not come within the ambit of this circular and a separate circular letter in respect of such category of pensioners / family pensioners will be issued separately on enhancement of such applicable rate.

4. In the case of retired Judges of the High Court, separate circular will be issued on receipt of necessary order from the Ministry of Law and Justice (Department of Justice).
5. Amount of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
6. The payment of arrears of Dearness Relief shall not be made before the date of disbursement of pension / family pension of October, 2024.
7. It will be the responsibility of the pension disbursing authorities, including nationalized banks etc. to calculate the quantum of Dearness Relief payable in each individual case.
8. All concerned Pension Disbursing Officers are, therefore, requested to make necessary arrangement for payment of Dearness Relief @ 53% to the above eligible categories of pensioners/ family pensioners with effect from 01/07/2024, along with arrear of dearness relief following the above guideline, as applicable, after proper adjustment.
9. Charges for payment of above enhanced rate of dearness relief to the pensioners / family pensioners are debitable to the Government of India/Railway/Defence Accounts under the proper head of account as usual.

The Government of India have enhanced the existing rate of Dearness Relief on Pension / Family Pension from 50% to 53% of the Basic Pension/ Family Pension (including additional pension/family pension) with effect from 01/07/2024 in O.M.No.42/02/2024-P&PW(D), dated 30/10/2024 of the Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Pension and Pensioners' Welfare, New Delhi.

2. The Government of Puducherry has communicated the Orders of Government of India for extending the revised rate of Dearness Relief @ 53% with effect from 01/07/2024 to the Pensioners / Family Pensioners of the Union Territory of Puducherry vide G.O. Ms. No.48/FD/F3/A2/2024-25, dated 13/11/2024 of the Finance Department, Puducherry.

3. On the basis of the above orders, I am to authorize to effect payment of Dearness Relief at the revised rate of 53% as mentioned above with effect from 01/07/2024 to all eligible Pensioners / Family Pensioners of Union Territory of Puducherry drawing Pension from the Banks / Treasuries / Sub-Treasuries under your control subject to conditions governing the payment of Dearness Relief on Pension / Family Pension as detailed in the Government of India Office Memorandum aforesaid.



OFFICE MEMORANDUM

Subj: Grant of Dearness Relief to Central Government pensioners/Family pensioners - Revised rate effective from 01.07.2024-rcg

The undersigned is directed to refer to this Department's OM No. 42/02/2024-P&PW(D) dated 13.03.2024 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government Pensioners/Family Pensioners shall be enhanced from the existing rate of 50% to 53% of the basic pension/family pension (including additional pension/family pension) w.e.f 01st July, 2024.

2. These rates of DR will be applicable to the following categories:-

- (i) Civilian Central Government Pensioners/Family Pensioners including Central Govt. absorbee pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D) Vol. II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years.
- (ii) The Armed Forces Pensioners/Family Pensioners and Civilian Pensioners/Family Pensioners paid out of the Defence Service Estimates.
- (iii) All India Service Pensioners/Family Pensioners.
- (iv) Railway Pensioners/Family Pensioners.
- (v) Pensioners who are in receipt of provisional pension
- (vi) The Burma Civilian Pensioners/Family Pensioners and Pensioners/families of displaced Government Pensioners from Burma/Pakistan, in respect of whom orders have been issued vide this Department's OM No. 23/3/2008-P&PW(B), dated 11.09.2017.

3. The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

4. The payment of arrears of Dearness Relief shall not be made before the date of disbursement of pension/family pension of October, 2024.

5. Other provisions governing grant of DR in respect of employed family pensioners and re-employed Central Government Pensioners will be regulated in accordance with the provisions contained in Rule 52 of CCS (Pension) Rules, 2021 and this Department's OM No. 45/73/97-P&PW (C) dated 2.7.1999 as amended from time to time. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.

6. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.


7. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.

8. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of Dearness Relief to Pensioners/Family Pensioners on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528- TA, II/34-80-II dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (GGL)/81 dated the 21 st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.

9. In so far as the pensioners/family pensioners of Indian Audit and Accounts Department are concerned, these orders are issued in consultation with the Comptroller and Auditor General of India, as mandated under Article 148(5) of the Constitution of India.

10. This issues in accordance with the Ministry of Finance, Department of Expenditure's OM No. 1/5/2024-E-II(B) dated 21.10.2024 and approval of C&AG vide ID Note No. भारत के नि.म.ले.प.यू.ओ.सख्या-339 स्टाफ हक (नियम)/AR/02-2020) dated 30.10.2024.

Sub: - Grant of Dearness Relief to State Government Pensioners/ Family Pensioners - Revised rate effective from 01/07/2024.

1. The Government of Goa, Finance (Rev. & Cont.) Department Secretariat, Porvorim, vide letter No.12/3/82-Fin(R&C)/Vol.II/27061 dated 11th November 2024 have conveyed the sanction for revision of Dearness Relief to the Pensioners/Family Pensioners of Goa Government as contained in Office Memorandum No. 42/02/2024-P&PW (D) dated 30th October 2024 issued by Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Pension, & Pensioner's Welfare, New Delhi. The copy of the said Office Memorandum is enclosed for information and necessary action.
2. Since the order on relief contained in the above Government of India's Office Memorandum is adopted and made applicable to the Goa Government Pensioners and Family Pensioners, I am to authorize you to pay to the Goa Government Pensioners/Family Pensioners enhanced Dearness Relief @ 53% from existing 50% with effect from 01/07/2024.
The Dearness Relief @ 53% is to be paid to the Pensioners w.e.f. 01/07/2024 and is to be released alongwith the arrears from 01/07/2024 to 31/10/2024, in the monthly pension payable from month of November, 2024. It is also applicable to the following pensioners.
 - (a). Ex-gratia pensioners (Montepio pensioners, pensioners drawing pensions on account of service rendered to Portuguese colonies and institute Ultramarine Pensioners) drawing pensions under C/B/D and E series.
 - (b). Pensao de Sanguie pensioners.
 - (c). Pensioners receiving pension under triple benefit scheme.
 - (d). Recipients of Ex-gratia i.e. Families of deceases pensioners/employees who were governed under EFU.
 - (e). Pensioners sanctioned pension under Education Act 15 of 1985 and drawing pension under pension payment series T and E.B.
3. In case of Goa State Government Pensioners drawing pension in other States, the instructions contained in above Office Memorandum may be issued to all the Treasuries/Sub-Treasuries/P.A.O where they are drawing their monthly pension.
4. This Dearness relief is not applicable to the following class of pensioners.
 - a. Pensioners drawing pension, which is granted after Independence for Political consideration (Ex-Rulers).
 - b. Retired High Court and Supreme Court Judges for whom order will be issued separately by administrative authorities concerned.
 - c. Pensioners of other states (PAO) Suspense for whom separate orders are applicable.
 - d. M.L.A. Pensioners.
 - e. Freedom Fighters of Govt. of Goa.
5. Instructions issued from time to time by this office as regards to payment of relief should be observed.
6. Wide Publicity may be given to this circular letter by displaying a copy on the office notice board or other permanent place in your office.

Subject: Grant of Dearness Relief to Central Government pensioners/family pensioners - Revised rate effective from 01.07.2024-reg.

The undersigned is directed to refer to this Department's OM No.42/04/2023-P&PW (D) dated 13.03.2024 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government Pensioners/ Family Pensioners shall be enhanced from the existing rate of 50% to 53% of the basic pension/family pension (including additional pension/family pension) w.e.f. 01st July,2024.

Cont...

2. These rates of DR will be applicable to the following categories:-

- (i) Civilian Central Government Pensioners/ Family Pensioners including Central Govt. absorbee pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D)Vol.II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years.
- (ii) The Armed Forces Pensioners/Family Pensioners and Civilian Pensioners/Family Pensioners paid out of the Defence Service Estimates.
- (iii) All India Service Pensioners/Family Pensioners.
- (iv) Railway Pensioners/Family Pensioners.
- (v) Pensioners who are in receipt of provisional pension.
- (vi) The Burma Civilian Pensioners/Family Pensioners and Pensioners/ families of displaced Government pensioners from Burma/Pakistan, in respect of whom orders have been issued vide this Department's O.M. No.23/3/2008-P&PW(B) dated 11.09.2017.

3. The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

4. The payment of arrears of Dearness Relief shall not be made before the date of disbursement of pension/family pension of October, 2024.

5. Other provisions governing grant of DR in respect of employed family pensioners and re-employed Central Government Pensioners will be regulated in accordance with the provisions contained in Rule 52 of CCS(Pension) Rules, 2021 and this Department's O.M. No.45/73/97-P&PW(G) dated 2.7.1999 as amended from time to time. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.

6. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.

7. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.

8. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of Dearness relief to Pensioners/Family Pensioners on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No.528-TA,II/34-80-II dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No.GANB No.2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.

9. In so far as the persons serving in Indian Audit and Accounts Department are concerned, these orders are issued in consultation with the Comptroller and Auditor General of India, as mandated under Article 148 (5) of the Constitution of India.

10. This issues in accordance with the Ministry of Finance, Department of Expenditure's O.M. No.1/5/2024-E-II(B) dated 21.10.2024 and approval of C&AG.

Subject: Release of further installment of 5% Dearness Relief w.e.f. 1st November, 2024.

The undersigned is directed to refer to the subject mentioned above and to state that the Governor of Tripura is pleased to decide grant of further installment of Dearness Relief @ 5% over the basic pension/ basic family pension as admissible under Tripura State Civil Services (Revised Pension) Rules, 2017 read with its 1st Amendment, 2018, with effect from 01-11-2024 to the State Government pensioners and family pensioners. With the release of this installment, total quantum of Dearness Relief payable to the State government pensioners and family pensioners with effect from 01-11-2024 shall stand at 30 % (25 % + 5 %) over the basic pension/ family pension, as the case may be.

2. The payment of account of Dearness Relief involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.

3. The Pension Disbursing Authorities including Public Sector Banks handling disbursement of pension/ family pension to the State Government Pensioners / Family Pensioners are authorized to calculate and disburse Dearness Relief at the above rate and manner in each individual case from 01-11-2024.

4. The expenditure on payment of Dearness Relief on pension/ family pension to the State Government Pensioners / Family Pensioners respectively shall be debit to the Major Head '2071-Pension and other Retirement Benefits'.

3. An employee can avail the grant only once in any financial year and only in a single installment and for a single festival only.

4. A declaration from concerned employee has to be taken stating that he/she has not availed Festival Grant for more than one occasion in any Financial Year.

5. An employee can take festival grant on the occasion of any one of the


