ORDER:

In the Government Order first read above, orders were issued sanctioning the revised rate of Dearness Allowance to the State Government Pensioners / Family Pensioners as detailed below:-

Date from which payable Rate of Dearness Relief month		
From 01-07-2016	132% of Basic Pension / Family Pension	

2. The Government of India, in its Office Memorandum second read above has conveyed its decision on admissibility of the Dearness Relief to its Pensioners / Family Pensioners subsequent to implementation of the Seventh Central Pay Commission recommendations and has enhanced the Dearness Allowance to its Pensioners from 2% to 4% of the basic pension with effect from 1.1.2017



- **3.** In the Government order third read above, orders were issued revising the Dearness Allowance of State Government employees and teachers to 136% with effect from 01-01-2017, following the Government of India's decision on enhancing the Dearness Allowance to its employees drawing pay in pre-2016 Scales of Pay.
- **4.** The Government after careful consideration of the fact that the pension / family pension is yet to be revised, has decided to enhance the Dearness Allowance of State Government Pensioners / Family Pensioners by 4% with retrospective effect from 01-01-2017 as allowed to Government employees and teachers. Accordingly, Government sanction the revised rate of Dearness Allowance to the State Government Pensioners / Family Pensioners as indicated below:-

Date from which payable	Revised rate of Dearness Allowance (per`month)	
1 st January, 2017	136% of Pension / Family Pension	

- **5.** The Government also direct that the arrears of enhanced Dearness Allowance for the months of January to April 2017, be drawn and paid by existing cashless mode of Electronic Clearance System (ECS).
- **6.** While arriving at the revised Dearness Allowance, fraction of a rupee shall be rounded off to the next higher rupee if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise. It will be the responsibility of the Pension Disbursing Authority including Public Sector Banks to calculate the quantum of Dearness Allowance payable in each individual case.
- **7.** Pending formal authorisation by the Principal Accountant General, the revised Dearness Allowance shall be paid straightaway by the Pension Pay Officer, Chennai, Treasury Officers and Public Sector Banks concerned.
 - 8. This order will apply to the following categories of pensioners:-
 - (i) Government Pensioners, Teacher Pensioners of aided and local body educational institutions and other pensioners of local bodies.
 - (ii) The State Government employees who had drawn lumpsum payment on absorption in Public Sector Undertaking / Autonomous Body / Local Body / Co-operative institution and have become entitled to restoration of 1/3rd commuted portion of pension as well as revision of the restored amount.
 - (iii) Present and future family pensioners; In the case of divisible family pensioners, Dearness Allowance shall be divided proportionately.
 - (iv) Former Travancore-Cochin State pensioners drawing their pension on 1st November, 1956 in the Treasuries situated in the areas transferred to Tamil Nadu State on that date, i.e. Kanniyakumari District and Shencottah Taluk of Tirunelveli District.

- (v) Pensioners who are in receipt of special pensions under Extra-ordinary Pension Rules, Tamil Nadu and Compassionate Allowance.
- **9.** The expenditure on Dearness Allowance payable to the Pensioners and Family Pensioners shall be debited to the respective following Heads of Account:
 - "2071. Pension and Other Retirement Benefits 01. Civil 101. Superannuation and Retirement Allowances State's Expenditure AC. Dearness Allowance to Pensioners 03. Dearness Allowance (D.P.C. 2071 01 101 AC 0306)"
 - "2071. Pension and Other Retirement Benefits 01. Civil 105. Family Pensions State's Expenditure AC. Dearness Allowance to Family Pensioners of Tamil Nadu Government 03. Dearness Allowance (D.P.C. 2071 01 105 AC 0308) ".
- 10. The orders regarding sanction of Dearness Allowance to the widows and children of the deceased Contributory Provident Fund / Non Pensionable Establishment beneficiaries of State Government and the former District Boards who are drawing ex-gratia will be issued separately.
- 11. The increased expenditure due to the sanction of Dearness Allowance in this order is allocable among the successor States as per the provisions laid down under the State Reorganization Act, 1956.

ORDER:

Government hereby order the revision of rates of Dearness Relief to pensioners sanctioned in the G.O. 9th above from 18.340% of the pension to 22.008% w.e.f 01.07.2016 in respect of:-

- (i) Those who retired from service after 01.07.2013 and are drawing pension in the Revised Pay Scales, 2015.
- (ii) Those who retired prior to 01.07.2013 and whose pension was consolidated in the light of orders issued in the G.O. 3rdread above.
- 2. Government also hereby order the revision of rates of Dearness Relief from 93.304 % to 99.296% with effect from 01.07.2016 to the pensioners who are drawing their pension in revised pay scales, 2010 and not consolidated in terms of the orders issued in the reference 3rd read above.
- 3. Government also hereby order the revision of rates of Dearness Relief to the pensioners who retired while drawing UGC Pay Scales 2006 from 01.01.2006 from 125% to 132% w.e.f. 01.07.2016.

- 4. Government also hereby order the revision of rates of Dearness Relief to the pensioners/family pensioners whose pension was consolidated as per orders issued in G.O.Ms.No.54, Higher Education (UE.II) Department, dated.08.06.2011 and G.O.Ms.No.31, Higher Education(UE.II)Department,dated24.05.2013 from 125% to 132% with effect from 01.07.2016.
- 8. Government also hereby order the revision of rates of Dearness Relief sanction G.O.Ms.No.4, Law (Law & J-SC.F) Department, dated.06.0 1.2011 to the Pensioners who are drawing pension as per Justice E.Padmanabhan Committee report from125% to 132 %with effect from 01-01-2016.
- 9. These orders are applicable to:
 - (1) (a)All government Pensioners in receipt of Service Pensions, Family Pensions under Revised Pension Rules, 1951, Andhra Pradesh Liberalised Pension Rules, 1961 and Andhra Pradesh Government Servants (Family Pension) Rules, 1964.
 - (b)Teaching and Non Teaching pensioners of Municipalities, Panchayat Raj Institutions and Aided Educational Institutions, in receipt of pensions under the Andhra Pradesh Liberalised Pension Rules, 1961 and Andhra Pradesh Government Servants (Family Pension) Rules, 1964.
 - (c) Teaching and Non Teaching staff in Aided Educational Institutions in receipt of pensions under the Contributory Provident Fund cum pension and Gratuity Rules, 1961 and Andhra Pradesh Liberalised Pension Rules, 1961.
 - (d) Those drawing family pensions under G.O.Ms.No.22 Finance & Planning (FW-Pen.I) Departmentdt. 16.11.1971, G.O.Ms.No. 104 Finance & Planning (FW-Pen.I) Department dt. 13.04.1973 and G.O.Ms.No.25 Finance & Planning (FW-Pen.I) Department dt. 02.02.1974.
 - (e)Pensioners in receipt of compassionate pension under the rules for Compassionate Pensions and Gratuities in the Hyderabad Civil Services Rules; and
 - (f) Those in receipt of Pensions under the Wound and the Extraordinary Pension Rules.
 - (2) Jagir and Estate pensioners and
 - (3) Pensioners governed by the Telangana Revised Pension Rules, 1980.

- 10. These orders are not applicable to financial assistance grantees and others who are not entitled to Dearness Relief.
- 11. The amount of Dearness Relief shall be rounded off to the next rupee.
- 12. The arrears of revised Dearness Relief to the pensioners shall be paid along with the pension of April 2017 payable on 1^{st} May 2017.
- 13. All the Treasury Officers/Pension Payment Officers shall workout and make payments of the Dearness Relief on Pension sanctioned in this order without waiting for further authorization/instructions from the Accountant General(A&E), Telangana and Andhra Pradesh, Hyderabad, in terms of the orders issued in the G.O.Ms.No.270, Finance &Planning(FW:PSC.I)Department 'dt. 7.10.1986.
- 14. All the Treasury Officers/Pension Payment Officers shall workout and make payments of the Dearness Relief on Pension sanctioned in this order in terms of ordersissuedinG.O.Ms.No.122 Finance (Pen.I) Department, dt.22.05.2014.
- 15. The expenditure is allocable among the various States in accordance with provisions of Rule 24 of the Incidence of Pension Rules in Appendix III-B of the Andhra Pradesh Accounts Code, Volume-I.
- 16. In respect of the categories of employees who are not covered for payment through the Treasuries, the expenditure shall be debited to the Pension Funds of Zilla Parishads and Pension Funds of the respective Municipal Councils.
- 17. In respect of the Pensioners of the Universities the expenditure on account of the Dearness Relief now sanctioned above shall be met from the Block Grants allotted to them.

MEMORANDUM

Subject: Grant of ex-gratia payment to the State Government Pensioners.

The undersigned is directed by order of the Governor to say that in order to provide some relief to the State Government Pensioners during the ensuing festivals, the Governor has been pleased to decide that all State Government Pensioners including the holders of provisional pension who retired prior to 30.9.2016 and also the pensioners who retired or died after 30.9.2016 but prior to 01.09.2017 and whose basic pension plus relief on pension as on March 31, 2017 did not exceed Rs. 25000/-(Rupees twenty five thousand) only and are not eligible for ad-hoc bonus shall be paid an exgratin grant of Rs. 1900/- (Rupees One thousand and nine hundred) only in lump per head.

- 2. The charge is debitable to the head "2071-Pensions and other retirement Benefits-01Civil-800-other Expenditure-NP-001-fund required for meeting other expenditure-V-04-Pension / Gratuities" during the current financial year.
 - 3. The ex-gratia grant sanctioned herein will also be admissible to:
 - i) The holders of family pension, ex-gratia family pension and adhoc family pension;
 - ii) Pensioners (including widow pension holders) who draw their pension sanctioned under French Pension Rules;
 - iii) Holders of extra-ordinary pension; and
 - iv) Holders of ex-gratia pension.

The benefit will also be admissible to the pensioners of the undivided Government of Bengal and the pensioners of the erstwhile East Pakistan (now Bangladesh) Government who migrated to West Bengal and are receiving pension under "Provisional Payment of Pension Scheme".

- 4. The ex-gratia grant sanctioned herein <u>will not be admissible</u> to the special categories of pensioners, such as:
 - i) Pensioners who have migrated from Pakistan;
 - ii) Political Pensioners;
 - iii) Special Pensioners;
 - iv) War Risk Pensioners;
 - v) Pensioners governed by the All India Services Rules.
 - 5. The benefit will also not be admissible to those who are entitled to ad-hoc bonus sanctioned by the State Government and those who are employed/re-employed under any Public Undertakings/Statutory Bodies under the Government and are in receipt of bonus or ex-gratia payment in lieu there of during the current financial year.
 - 6. State Government pensioners who draw their pension through Public Sector Banks will get this ex-gratia grant through their respective Bank Accounts. The Principal accountant General (A&E), West Bengal will issue an authority for this purpose to all such Banks under the Kolkata Payment Scheme immediately on receipt of this order so that the pensioners may draw the exgratia grant immediately to make their commitments for their festival. The Treasury/Sub-Treasury Office will take appropriate steps for issue of cheque to the respective paying branches of the Banks and Post Offices, so that the pensioners receiving pension through Banks and Money Order get the payment of ex-gratia immediately to meet their commitments for their festival. No authority of the Principal Accountant General (A&E), West Bengal will be required for this purpose.

7. Subject to para 6 above, this order will also be applicable to those who are eligible for this ex-gratia grant but whose pension/family pension has not yet been sanctioned. In their cases and in the case of persons who are drawing provisional pension, this amount of ex-gratia will be drawn by the authority competent to draw provisional pension in the same manner as the amount of provisional pension is drawn by him. In their cases, the facts of payment of ex-gratia grant should be intimated to the Principal Accountant General (A&E), West Bengal at the time of forwarding their pension papers for final sanction of pension.

This benefit of ex-gratia grant of Rs. 1900/- per head as has been sanctioned in this memorandum for the State Government Pensioners will also be allowed to the teaching and non-teaching Pensioners of State aided Non-Government Educational Institutions and Pensioners of Panchayats, the Pensioners of Municipal Corporations/Municipalities/Local Bodies and other Organisations for whom pension is authorised either by the Accountant General, West Bengal or the DPPG, West Bengal. In such cases the respective Administrative Department may sanction the benefit of ex-gratia payment @ Rs. 1900/- per head this year to the pensioners concerned under their control without making any further reference to Pension Branch of this Department.

The payment of ex-gratia as sanctioned herein above should be made by 19th June, 2017 for the Muslim Pensioners / Family Pensioners and other than Muslim Pensioners / Family Pensioners the benefits should be disbursed in between 11th September, 2017 to 18th September, 2017.
