Subject : Regarding data collection in respect of Govt. of West Bengal pensioner/family pensioners drawing pension in other States for calculation and payment of arrear of Dearness Relief in pursuance of Judgement of Hon'ble Supreme Court Of India.

Sir,

In compliance with the judgement of the Hon'ble Supreme Court of India, the Government of West Bengal, Finance Department has issued Notification No. 997-F(P2) dated 13.03.2026 to pay the arrears of Dearness Relief (DR) pertaining to the period from April 2008 to December, 2019 to the West Bengal Government pensioners/family pensioners. It has been decided by the Government that the arrears for the period from January, 2016 to December, 2019 will be paid in the first phase.

With a view to determine the total financial implications involved in respect of arrear of dearness relief to be paid and to arrive at the amount for payment in the first phase to each individual pensioner, the Government of West Bengal in consultation with this office has devised a format in excel sheet for collection of the required information from the disbursing authorities.

In enclosing the said format, it is requested to circulate the excel sheet among the pension disbursing authorities of your State/jurisdiction for populating the data as available with them into the sheet and forwarding the same to your office for onward transmission to this office. The details of individual pension paid – month wise for the period from January 2016 to December 2019 may be sent immediately but not later than 10/04/26 and the rest data may be sent by end of this month.

In order to comply with the direction of the Hon'ble Apex Court in a time bound manner, it is requested to complete the 1st phase of the exercise by 10/04/2026 so that the data sheet may be sent to the Government of West Bengal by this office at the earliest for taking further action regarding payment of arrear of dearness relief to the West Bengal Government pensioners/family pensioners, drawing pension from your state, prior to the next date of hearing scheduled to be held on 15/04/2026.

An immediate action is highly solicited.
