2. - 4. Temporary Increase will be admissible on the amount of basic pension/family pension plus 50% of merged Dearness Relief as per the Govt. Resolution dated: 1/9/ 2005.
- 5. The arrears of difference payable under these orders shall be paid in cash.
  6. Other terms and conditions in the Govt. Resolutions read above shall be applicable to the pensioners/ family pensioners for the Temporary Increase.
