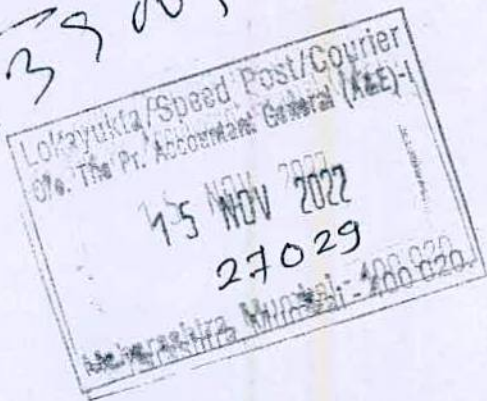

**Subject: Payment of Dearness Relief @ 38 % to Haryana Government pensioners and family pensioners w.e.f. 1<sup>st</sup> July, 2022.**

The Governor of Haryana is pleased to enhance the Dearness Relief payable to Haryana Government pensioners and family pensioners, who are drawing their pension/family pension as per 7<sup>th</sup> pay/pension structure, from existing rate of 34% to 38% of the basic pension with effect from 1<sup>st</sup> July, 2022.

2. Enhanced DR shall be paid with the pension of October, 2022 and arrear for the months of July, 2022 to September, 2022 shall be paid in the month of November, 2022. The payment on account of Dearness Relief involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored. All other conditions for payment of Dearness Relief to Pensioners & Family Pensioners on revised Pension & Family Pension contained in FD's instructions No. 2/23/2016-1 Pension dated 3<sup>rd</sup> March, 2017 shall remain same.
