- 4. This Dearness Relief is only applicable to the Goa State Freedom Fighter
 Pensioners/ Family Pensioners.
- Instructions issued from time to time by this office as regards to payment of relief should be observed.

 notice board or other permanent place in your office.
- 7. Pensioners who have drawn part payment of their pension through Treasury Office after 01/07/2016 and have subsequently opted for payment of their pension through Bank may also be paid arrears without waiting for any individual orders from this office.
