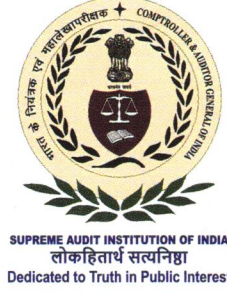

RESOLUTION

The Pensioners/Family Pensioners who are getting pension/family pension according to Pay Scale of G.C.S.R. (Revision of pay), Rule 2009 (6th Pay Commission) have been accorded Temporary Increase (T.I.) up to 257% vide Government Resolution as mentioned at (III) above.

Now, the State Government has decided to increase the rates of Temporary Increase (Dearness Relief) admissible to State Government pensioners/family pensioners, who are getting pension/family pension according to Revision of Pay Rules, 2009 (6th Pay Commission) as under.

No.	Admissible from date	Admissible Rate
1.	From 01/01/2026	262% of the basic pay

1. Payment of Temporary Increase (Dearness Relief) involving a fraction of a rupee shall be rounded off to the nearest rupee (lower or higher).
2. Temporary Increase (Dearness Relief) at the rates indicated in above table will also be admissible on the additional basic pension/additional family pension available to Pensioners/Family Pensioners based on their age as indicated in Government Resolution, Finance Department, No.PGR-1009-4 & 5-Pay Cell, Dated : 13/04/2009 and Government Resolution, Finance Department No. PGR-102016-6-Pay Cell, Dated: 15/10/2016.
3. The Temporary Increase as 262% will be paid regularly along with monthly pension from May-2026, the difference of months from January-2026 to April-


2026 of the proposed Temporary Increase will be paid in one installment along with salary of May (Paid in June-2026) after the resolution is published.

4. It will be the responsibility of the Pension Disbursing Authority, to calculate the quantum of Dearness Relief payable in each individual case.

5. All Accountant General of the respective States/Central Administrative Authority except Gujarat State are requested to take necessary action to authorize all the disbursing authorities under their control for making payment to Gujarat Pensioners drawing pension from their State Treasuries, Including Public Sector Banks.

6. Other Provisions governing grant of temporary Increase (Dearness Relief) to Pensioners such as regulations of dearness relief during employment/re-employment, regulations to temporary increase (Dearness Relief), where more than one pension is drawn etc. will remain unchanged.


