Ref: 1. Office Memorandum F.No.42/10/2014-P&PW(G) dated 29.09.2014 of Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Pension and Pensioners Welfare.

2. GO(Ms) No.55/2011/Home dated 24.2.2011

As per OM cited 1st, the Dearness Relief payable to the Central Government pensioners/family pensioners has been enhanced from the existing rate of 100% to 107% with effect from 1.7.2014.

Government of Kerala as per orders cited 2nd have extended the benefit of increase in Dearness Relief sanctioned to Central Government pensioners/family pensioners to the pensioners/family pensioners coming under the category of the State Judicial Officers, without further orders from the State Government.

Hence, you are requested to honour the claim for enhanced rate of Dearness Relief with effect from 1.7.2014 at the rate of 107%, preferred by the pensioners/family pensioners coming under the category of the State Judicial Officers in respect of whom pension/family pension has been revised based on replacement scale came into force with effect from 1.1.2006.
