After careful consideration of the matter, the State Government have been pleased to decide that Dearness Relief (T.I) on pension/ family pension shall be paid to the State Government pensioners/ family pensioners at the same rate of 4% on the revised basic pension/ family pension and provisional pension with effect from 01.01.2024.
