Subject: Payment of Dearness Relief @ 42 % to Haryana Government pensioners and family pensioners w.e.f. 1st January 2023.

The Governor of Haryana is pleased to enhance the Dearness Relief payable to Haryana Government pensioners and family pensioners, who are drawing their pension/family pension as per 7th pay/pension structure, from existing rate of 38 % to 42 % of the basic pension with effect from 1st January, 2023.

- 2. Enhanced DR and arrear shall be paid with the pension payabale in the correct method. The payment on account of Dearness Relief involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored. All other conditions for payment of Dearness Relief to Pensioners & Family Pensioners on revised Pension & Family Pension contained in FD's instructions No. 2/23/2016-1Pension dated 3rd March, 2017 shall remain same.
