**Sub: Grant of Dearness Allowance to pensioners of Karnataka State
with effect from 01-01-2023**

I am to invite a reference to Government of Karnataka, Finance Department Order No. FD 9 SRP 2023, BANGALORE dated 30.05.2023, and to authorize you to pay DA at 35% (from 31 %) of the revised basic pension / family pension with effect from 01-01-2023, to the State Government pensioners/family pensioners of Karnataka including the pensioners/family pensioners of the Aided Educational Institutions whose pension/family pension is paid out of Consolidated Fund of the State .

These Orders are applicable to the pensioners of UGC/AICTE/ICAR Scales of pay.

Separate Orders will be issued in respect of NJPC Pensioners.
