Subject: - Grant of Dearness Relief to State Govt Pensioners/family pensioners - Revised rate effective from 01-01-2022.

In pursuance to the Govt. of India, Ministry of Personnel, Public Grievances & Pensions' OM No.42/07/2022-P&PW(D) dated 5/4/2022 (copy enclosed) on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to order that the Dearness Relief (DR) payable to State Government Pensioners/Family Pensioners shall be enhanced by 3% from the existing rate of 31% to 34% with effect from 1<sup>st</sup> January, 2022.

All other terms and conditions as enunciated in the Govt. of India, Ministry of Personnel, Public Grievances & Pensions' OM No.42/07/2022-P&PW(D) dated 5<sup>th</sup> April, 2022 shall remain unchanged.

This is issued with the approval of the Competent Authority.


