

Subj: - Grant of Dearness Relief to Goa State Freedom Fighter Pensioners of Government of Goa-Revised rate effective from 01/07/2021 @ 196%, from 189%.

1. The Government of Goa, Department of Home (General), Secretariat, Porvorim-Goa, vide letter No. 11/4/2012-HD(G)/6695 dated 25th May 2022 have conveyed the sanction for revision of Dearness Relief to Goa State Freedom Fighters. The copy of the said letter is enclosed for information and necessary action.
2. Since the order on relief contained in the above Government of Goa's Letter are applicable to Goa Government Freedom Fighters and Goa Freedom Fighter Family Pensioners under Freedom Fighter Welfare Rules, 2013, I am to authorize you to pay to the Goa Government Freedom Fighters Pensioners/Family Pensioners the installment of 7% of Dearness Relief raising it from **189% to 196% with effect from 01/07/2021.**
3. In case of Goa State Freedom Fighters/Family Pensioners drawing pension in other States, the instructions contained in above Letter may be issued to all the Treasuries/Sub-Treasuries/P.A.O where they are drawing their monthly pension.
4. **This Dearness Relief is only applicable to the Goa State Freedom Fighter Pensioners/ Family Pensioners.**
5. Instructions issued from time to time by this office as regards to payment of relief should be observed.
6. Wide Publicity may be given to this circular letter by displaying a copy on the office notice board or other permanent place in your office.
7. Pensioners who have drawn part payment of their pension through Treasury Office after 01/07/2016 and have subsequently opted for payment of their pension through Bank may also be paid arrears without waiting for any individual orders from this office.
