Government is pleased to decide that the rate of dearness relief with effect from 1st January, 2022 will be revised from 196% to 203% to the State Government pensioners /family pensioners who are drawing pension in the pre-revised scale (As per Sixth Pay Commission). Revised dearness relief with arrears from 1st January 2022 will be payable in cash with pension / family pension of the month of August 2022.
