

Government is pleased to decide that the rate of dearness relief with effect from 1st January, 2022 will be revised from 31% to 34% to the State Government pensioners /family pensioners on their Basic Pension/Family Pension. Revised dearness relief with arrears from 1st January 2022 will be payable in cash with pension / family pension of the month of August 2022.

- 2. It will be the responsibility of the Pension Disbursing Authority, i.e. the Pay and Accounts Officer, Mumbai/Treasury Officers, as the case may be, to calculate the quantum of dearness relief payable in each individual case.
- 3. Government is also pleased to direct that above decision should mutatis mutandis, apply to those pensioners including family pensioners of Recognised and Aided Educational Institutions, Agricultural / Non-Agricultural Universities and Affiliated Non-Government colleges to whom the pension scheme is made applicable...

Government is pleased to decide that the rate of dearness relief with effect from 1st January, 2022 will be revised from 196% to 203% to the State Government pensioners /family pensioners who are drawing pension in the pre-revised scale (As per Sixth Pay Commission). Revised dearness relief with arrears from 1st January 2022 will be payable in cash with pension / family pension of the month of August 2022.

- 2. It will be the responsibility of the Pension Disbursing Authority, i.e. Pay and Accounts Officer, Mumbai/Treasury Officers, as the case may be, to calculate the quantum of dearness relief payable in each individual case.
