



The undersigned is directed to inform that the rate of "Festival Grant" for various categories of employees/ staff/ workers shall be as shown in the below table:

Sl. No.	Category of employees	Revised rate of Festival Grant
1.	Group - C (including employees recruited on Fixed Pay basis by keeping in abeyance the regular scale posts)	Rs. 1,800/-
2.	Group - D (including employees recruited on Fixed Pay basis by keeping in abeyance the regular scale posts)	Rs. 1,800/-
3.	DRWs who have been engaged with prior concurrence of Finance Department	Rs. 1,800/-
4.	PTWs/Contractual Workers/Casual Workers etc. who are engaged with prior concurrence of Finance Department (The copy of concurrence to be enclosed with the bill).	Rs. 2,000/-
5.	Pensioners / Family Pensioners	Rs. 1,800/-
6.	Anganwari Workers / Helpers	Rs. 2,000/-
7.	Home Guards / SPOs	Rs. 2,000/-

2. Regarding Workers/ Staff under Central Scheme, the concerned Department may decide.

3. An employee can avail the grant once in a financial year and only in a single installment and for a single festival only.

4. An employee can take festival grant on the occasion of any one of the following festivals:
