

Sub: Grant of Dearness Allowance to pensioners of Karnataka State
with effect from 1st January 2024

I am to invite a reference to Government of Karnataka, Finance Department Order No. FD 18 SRP 2024, BANGALORE dated 12th March 2024, and to authorize you to pay DA at 42.50 % (from 38.75 %) of the revised basic pension / family pension with effect from 01-07-2023, to the State Government pensioners/family pensioners of Karnataka including the pensioners/family pensioners of the Aided Educational Institutions whose pension/family pension is paid out of Consolidated Fund of the State.

These Orders are applicable also to the pensioners of UGC/AICTE/ICAR Scales of pay.

Separate Orders will be issued in respect of NJPC Pensioners.

These instructions may please be communicated to all the District / Sub-Treasury Officers under your control and CPPC's. A few copies of the Government Order are enclosed for reference. **GOVERNMENT ORDER NO. FD 18 SRP 2024,
BANGALORE, DATED 12th March 2024.**

Government are pleased to enhance the rates of Dearness Allowance payable to the State Government Employees in the 2018 Revised Pay Scales from the existing 38.75% to 42.5% of Basic Pay with effect from 1st January 2024.


2. For the purpose of this order, the term 'Basic Pay' means, pay drawn by a Government Employee in the scale of pay applicable to the post held by him and includes:

- a. Stagnation increment, if any, granted to him above the maximum of the scale of pay;
- b. Personal Pay, if any, granted to him under sub-rule (3) of Rule 7 read with Rule 3(c) of the Karnataka Civil Services (Revised Pay) Rules, 2018;
- c. Additional increment, if any, granted to him above the maximum of the scale of pay.

3. Basic Pay shall not include any emoluments other than those specified above.
4. Government are also pleased to enhance the rates of Dearness Allowance from the existing 38.75% to 42.5% of the Basic Pension/Family Pension with effect from 1st January 2024 to the State Government Pensioners/Family Pensioners as well as Pensioners/Family Pensioners of the Aided Educational Institutions whose Pension/Family Pension is paid out of the Consolidated Fund of the State.
5. These orders are also applicable to Pensioners on UGC/AICTE/ICAR scales of pay.
6. These orders will apply to the full time Government Employees, Employees of Zilla Panchayats, Work Charged Employees on regular time scales of pay, full time Employees of Aided Educational Institutions and Universities who are on regular time scales of pay.
7. Separate orders will be issued in respect of Employees on UGC/AICTE/ICAR scales of pay and in respect of Judicial Officers on NJPC Pay Scale.
8. The increase in Dearness Allowance admissible under this order is payable in cash.
9. The payment on account of Dearness Allowance involving fractions of 50 paise and above shall be rounded off to the next rupee and fractions less than 50 paise shall be ignored.
10. The payment of arrears of Dearness Allowance shall not be made before the date of disbursement of salary for the month of March 2024.

11. The Dearness Allowance will be shown as a distinct element of remuneration and will not be treated as pay for any purpose.
