Subject : **Grant of Dearness Relief to the Retired Judicial Officers / family pensioners of the State of West Bengal - revised rate effective from 01/07/2022**

The Government of West Bengal, Judicial Department under their letter No. 3095-J/JD/V/2A-14/2017 dated 20/10/2022 has communicated that the rate of dearness relief on basic pension/family pension for the retired Judicial Officers of Govt. of West Bengal and family pensioners of such category has been **enhanced from 203% to 212% with effect from 01/07/2022.**

Accordingly, in continuation to this office circular No. Pen. Co-ordn./65 Vol.V/28 dated 12/05/2022, all concerned Pension Disbursing Authorities are requested to make necessary arrangement for payment of Dearness Relief @ **212%** to the above category of pensioners / family pensioners with effect from **01/07/2022** after proper adjustments of payment already made.

Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

Charges for payment are debitable to the Govt. of West Bengal, under head 2071 – Pension and other Retirement Benefits – 01 – Civil – 101 Superannuation and Retirement allowances etc.
