विषय:— षष्ठम् केन्द्रीय वेतनमान में वेतन/पेंशन प्राप्त कर रहे राज्य सरकार के सरकारी सेवकों/पेंशनभोगियों/पारिवारिक पेंशनभोगियों को दिनांक— 01.01.2022 के प्रभाव से 196% के स्थान पर 203% महंगाई भत्ता/राहत की स्वीकृति के संबंध में।

वित्त विभाग के संकल्प सं0-8010/वि० दिनांक-29.11.2021 के द्वारा षष्टम् केन्द्रीय वेतनमान में वेतन/पेंशन प्राप्त कर रहे राज्य सरकार के सरकारी सेवकों/पेंशनभोगियों/पारिवारिक पेंशनभोगियों को केन्द्र सरकार के अनुरूप दिनांक 01. 07.2021 के प्रभाव से 196 प्रतिशत की दर से महंगाई भत्ता/राहत की स्वीकृति प्रदान की गई थी।

- 2. भारत सरकार, वित्त मंत्रालय, व्यय विभाग के पत्रांक—1/3(1)/2008-E.II(B), दिनांक—07.04.2022 द्वारा षष्ठम् केन्द्रीय वेतनमान में वेतन प्राप्त कर रहे केन्द्र सरकार के किमीयों को महंगाई भत्ता की दर दिनांक—01.01.2022 के प्रभाव से 196% से बढ़ाकर 203% स्वीकृत किया गया है।
- 3. राज्य सरकार सामान्यतः अपने कर्मियों/पेंशनभोगियों/पारिवारिक पेंशन भोगियों को महंगाई भत्ता/राहत की स्वीकृति केन्द्र सरकार के अनुरूप उसी दर पर एवं उसी तिथि से करती रही है।
  - 4. अतः सम्यक् विचारोपरान्त निर्णय लिया जाता है कि-
    - (i) षष्ठम् केन्द्रीय वेतनमान में वेतन/पेंशन प्राप्त कर रहे राज्य सरकार कें सरकारी सेवकों/पेंशनभोगियों/पारिवारिक पेंशनभोगियों को दिनांक— 01.01.2022 के प्रभाव से 196% के स्थान पर 203% महंगाई भत्ता/राहत की स्वीकृति दी जाती है।
    - (ii) षष्ठम् केन्द्रीय वेतनमान में प्राप्त मूल वेतन (वेतन बैंड एवं ग्रेड—पे के योग) के आधार पर महंगाई भत्ता आकलित किया जायेगा तथा इसमें विशेष वेतन अथवा वैयक्तिक वेतन को शामिल नहीं किया जाएगा।
    - (iii) पेंशनभोगियों / पारिवारिक पेंशनभोगियों के संदर्भ में महंगाई राहतः मूल पेंशन के आधार पर परिगणित किया जाएगा।
    - (iv) महंगाई भत्ता/राहत की गणना में 50 पैसे या उससे अधिक पैसे अगले रूपये में पूर्णांकित कर दिया जायगा तथा 50 पैसे से कम राशि को छोड़ दिया जाएगा।



- (v) उपर्युक्त महंगाई भता / राहत की राशि का नगद भुगतान किया जाएगा। कोषागार पदाधिकारी द्वारा महालेखाकार / वित्त वैयक्तिक दावा निर्धारण कोषांग के प्राधिकार पत्र की प्रतीक्षा किये बिना देय भुगतान तत्त्वाल औपबंधिक रूप से कर दिया जाएगा।
- 5. उच्च न्यायालय, पटना/बिहार विधान सभा/बिहार विधान परिषद् के किर्मियों/पेंशनभोगियों/पारिवारिक पेंशनभोगियों को षष्ठम् केन्द्रीय वेतनमान में उक्त महंगाई भत्ता/राहत का भुगतान मुख्य न्यायाधीश, पटना उच्च न्यायालय/अध्यक्ष, बिहार विधान सभा/सभापति, बिहार विधान परिषद् की स्वीकृति से देय होगा।

#### GOVERNMENT OF BIHAR DEPARTMENT OF FINANCE RESOLUTION

Patna, Dated 09.05.2022

Sub:-Sanction of dearness allowance/relief of 203% instead of 196%, w.e.f. 01.01.2022 to the Government Servants/Pensioners/Family Pensioners of the State Government receiving pay / pension in the Sixth Central Pay Scale – reg.

Vide Department of Finance, Resolution No.8010/Vi. dated 29.11.2021, sanction had been accorded for dearness allowance/relief at the rate of 196% w.e.f. 01.07.2021 to the Government Servants/Pensioners/Family Pensioners of the State Government receiving pay/pension in the Sixth Central Pay Scale, in accordance with the Central Government.

- 2. Vide Government of India, Ministry of Finance, Department of Expenditure, OM No.1/3(1)/2008-E-II(B) dated 07.04.2022, sanction has been accorded to increase the rate of dearness allowance of Central Government employees receiving pay in the Sixth Central Pay Scale, from 196% to 203% w.e.f. 01.01.2022.
- 3. The State Government generally sanctions dearness allowance/relief to their employees/pensioners/family pensioners at the same rate and from the same date as the Central Government.
  - 4. Hence, after due consideration decision is taken that-
  - (i) Sanction is accorded for 203% dearness allowance/relief instead of 196%, w.e.f.01.01.2022, to the Government Servants/Pensioners/Family Pensioners of the State Government receiving pay/pension in the Sixth Central Pay Scale.
  - (ii) Dearness allowance will be calculated on the basis of the basic pay (sum of pay band & grade pay) received in the Sixth Central Pay Scale and it will not include Special Pay or Personal Pay.
  - (iii) With regard to the pensioners/family pensioners, dearness relief will be calculated on the basis of basic pension.
  - (iv) In the calculation of dearness allowance/relief, 50 paise or more shall be rounded off to next rupee and the amount less than 50 paise shall be ignored.
  - (v) The amount of above dearness allowance/ relief will be paid in cash. The Treasury Officer shall immediately make the due payment provisionally, without waiting for the authorization letter of the Accountant General/Finance Personal Claims Assessment Cell.
- 5. The above mentioned dearness allowance/relief in Sixth Central Pay Scale to the employees/pensioners/family pensioners of High Court, Patna/Bihar Legislative Assembly/Bihar Legislative Council will be payable with the sanction of the Honourable Chief Justice, Patna High Court/Speaker, Bihar Legislative Assembly/Chairman, Bihar Legislative Council.

ORDER: Ordered that this Resolution be published in the next edition of the Gazette of Bihar for the information of general public.
