

A representation has been received from Mrs. Nagarathna, W/o Lt. Sh. S. Padamnabhan (Retd. IAS) holder of PPO No. 10292/OA/HP (issued by your office) vide her email dated 20/09/2021 that she was receiving family pension @ Rs. 54,941/- p.m. w.e.f. 04/2020 to 09/2020 from P.N.B. J.P. Nagar Branch, Bengaluru (copy of her e-mail enclosed). Thereafter she has transferred her family pension from P.N.B. to S.B.I. BTM Layout Branch, Bengaluru.

On perusal of the representation it seems that Pension Disbursing Authority has paid pension allowance to family pensioner on revised family pension as per 7th CPC instead of pre-revised family pension. It is mentioned here that the pension allowance @ 5%, 10% & 15% is admissible to her on the pre-revised family pension drawn before 01/01/2016 i.e. Rs. 16,410/p.m. in terms of H.P. Govt. OM No. Fin(Pen)A(3)-1/09 dated 23/04/2014 and OM No. Fin(Pen)A(3)-47/2016 dated 05/06/2017 (copies enclosed).

It is therefore, requested that matter may be examined keeping in view of H.P. Govt. orders dated 23/04/2014 & 05/06/2017 mentioned above and all Pension Disbursing Authorities under your jurisdiction may be directed to pay pension allowance to all the A.I.S. officers of H.P. cadre on the pre-revised pension/family pension i.e. pension/family pension drawn before 01/01/2016. Excess payment of pension allowance, if any, paid against PPO No. 10292/OA/HP and in all other similar cases may also be recovered under intimation to this office.

The Govt. of Himachal Pradesh, is pleased to grant Pension Allowance to the Government Pensioners/Family Pensioners w.e.f.1st April,2014 as under:-

Age of Pensioner/Family Pensiner	Pension Allowance
From 65 years to less than 70 years	5% of basic Pension/Family Pension
From 70 years to less than 75 years	10% of basic Pension/Family Pension
From 75 years to less than 80 years	15% of basic pension/ family Pension

The Pension Allowance being an Allowance shall not form the part of basic Pension/Family Pension for the purpose of grant of Dearness Relief, meaning thereby, no **DR** will be admissible on Pension Allowance.

The Pension Allowance shall be admissible from the 1st day of the month in which his date of birth falls.

The Pension Allowance @5%, 10% and 15% shall also be admissible to the All India Services Pensioners(AIS officers) of Himachal Pradesh Cadre.
