

In pursuance to the Govt of India, Ministry of personnel, Public Grievances & Pension OM No.42//02/2024-P&PW(D) dated 13th March'2024(copy enclosed) on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to order that the Dearness Relief (DR) payable to State Government Pensioners/Family Pensioners shall be enhanced by 4% from the existing rate 46% to 50% of the basic Pension with effect from 1st January'2024. The DR arrears for the period from 1st January'2024 to 31st March'2024 shall be paid in cash.

This is issued with the approval of the Competent Authority.


