

### ORDER

Sub: Grant of Dearness Relief to State Government Pensioners.

The Governor is pleased to order that the existing rate of Dearness Relief sanctioned vide Finance Department Order of even number dated 14-03-2024 to the State Government Pensioners who are in receipt of superannuation, retiring, invalid, compensation, family and extraordinary pension etc. shall be revised from 50% to 53% with effect from 01-07-2024.

For the purpose of this order -

- (i) Pension/Family Pension in the case of pre-01-01-2016 retirees and where Family Pension was sanctioned prior to 01-01-2016, means the Revised Pension or Revised Family Pension, as the case may be, effective from 01-01-2016 in terms of Finance Department Memorandum No. F.12(6)FD(Rules)/ 2017 dated 30-10-2017 as amended vide Order No. F.12(6)FD(Rules)/ 2017 dated 09-12-2017 and F.12(6)FD(Rules)/ 2017 Pt.-I dated 06-06-2018.
- (ii) In the case of pensioners who retire from service on or after 01-01-2017 or where family pension is sanctioned for the first time on or after 01-01-2017, Pension/Family Pension means the Basic Pension/Basic Family Pension, as the case may be, in terms of Finance Department Notification No. F.12(6)FD(Rules)/ 2017 dated 30-10-2017 as amended vide Order No. F.12(6)FD(Rules)/ 2017 dated 09-12-2017.
- (iii) Dearness Relief will also be admissible on the additional quantum of pension / family pension allowed to the pensioners who have attained the age of 80 years and above.
- (iv) Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- (v) Other provisions governing grant of dearness relief to pensioners' such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc., will remain unchanged.
- (vi) This order shall also be applicable in case of Pensioners/Family Pensioners who are in receipt of provisional pension.

- (vii) This order shall not be applicable in case of Old Age Pensions, Political Pensions or any other kind of similar pensions, which are not related to the service rendered under Government.
- (viii) Dearness Relief at revised rates as above would also be admissible to pensioners who retired/retire from service of Panchayat Samiti or Zila Parishad and whose Pension Payment Orders have been issued by the Director, Local Fund Audit Department or Director, Pension and Pensioners' Welfare Department, Rajasthan, Jaipur.
- (ix) Cash payment shall be admissible from 01-07-2024.

#### NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996, namely:

- Short title and commencement. (1) These rules may be valied the Rajasthan Civil Services (Pension) (Second Amendment) Rules, 2024.
- (2) They shall be deemed to have come into force with effect from 01-04-2024.
- 2. Substitution of rule 54B.- The existing rule 54B of the Rajasthan Civil Services (Pension) Rules, 1996, hereinafter referred to as the said rules, shall be substituted by the following, namely:-
  - "54B. Additional Allowance to pensioners/family pensioners.- Allowance @5% of the basic pension/family pension on attaining the age of 70 years and @10% of the basic pension/family pension on attaining the age of 75 years to the pensioners/ family pensioners, as the case may be, shall be given. This allowance shall be given to pensioners family pensioners upto the age of 80 years and no dearness relief shall be payable on such allowance."
    - 3. Amendment of rule 67.- In rule 67 of the said rules,-
      - (i) for the existing expression "disabled", wherever occurring, the expression "specially abled" shall be substituted;
      - (ii) after the existing clause (e) and before the existing proviso, the following new clause (f) shall be inserted, namely:-
      - "(f) Specially abled siblings only in case where a deceased Government servent or pensioner is not survived by a widow or widower or a child or parents eligible for family pension:", and
      - (iii) after the existing proviso and before the existing explanation, the following new proviso shall be inserted, namely:-

"Provided further that the family pension to specialy abled sibling shall be payable if the disability existed before the death of the Government servant or pensioner. The other conditions as applicable for the son/daughter of Government servant/pensioner who is suffering from any disorder or disability of mind or is physically crippled or specially abled or blind or deaf and dumb shall be the same as provided in these rules."

- 4. Amendment of rule 87.- In rule 87 of the said rules, after the existing subrule (7), the following new sub-rule (8) shall be added, namely:-
  - "(8) The Pension sanctioning authority shall indicate in the pension payment order the name of the Government servant's spouse, if alive, as family pensioner and shall also indicate in the pension payment order, the names of the permanently specially abled child or children, dependent parents and specially abled siblings as family pensioners, if there is no other member of family to whom family pension may become payable."
