Maximum marks for each paper are 150. Pass marks in each paper would be 40% and aggregate would be 45% i.e. 338 marks out of total 750 marks (05 Papers). Relaxation of 5% of the maximum marks i.e. 7.5 marks in each paper will be admissible to the candidates belonging to SC/ST category. Minimum marks for exemption will be 50%.

The Examination will be held strictly in accordance with aforesaid schedule and will not be cancelled or postponed on any day in the event of it being declared Holiday for whatever reasons by the Govt. of India.

A candidate intending to appear in the exam should send his/her application in the prescribed proforma (copy attached) latest by **27-08-2021** positively to this office through registered post or hand over the same personally. Application received after due date will not be considered. The candidate will ordinarily not be allowed more than three chances and in special circumstances, three additional chances may be allowed by the Accountant General. It may also be noted that if a candidate fails to appear in the examination, it will be counted as a chance availed against total number of chances admissible to him.

**If it appears to the Appointing Authority, at any time, during or at the end of the period of probation that a Government servant has not made sufficient use of his opportunities or in not making satisfactory progress, the Appointing Authority may revert him to the post held substantively by him immediately preceding his appointment, provided he holds a lien thereon or in other cases may discharge or terminate him from service. A probationer reverted or discharged from service during or at the end of the period of probation shall not be entitled to any compensation.**

Venue for above said examination is **Multipurpose Hall** of this office and Index Number allotted to the intending candidate will be communicated to them in due course.
