- 1. The staff posted on sensitive posts (as per Office order dated 23.12.2024) will be rotated from sensitive posts generally after the lapse of continuous three years and such officials will not hold particular sensitive post for more than five years during posting in this office.
- 2. Change of posting from HQ to field audit in respect of SAOs/AAOs in Report Section will be done after completion of a minimum period of two years, keeping in view of suitability and nature of Report work. Further, posting in respect of Secretary to AG, AAOs and other staff posted in AG's secretariat will be at the discretion of the concerned AG.
