Sub:- Irregular Subscription of GPF By DAs, DAOs and Sr. DAOs.

Please refer to this office letter no. PAO-GPF/missing credits/2022-23/81 dated 25/05/2022 and PAO-GPF/missing credits/2022-23/84 dated 01/06/2022 respectively on the subject cited above vide which you were requested to issue advisory/instructions to all the DAs, DAOs and Sr. DAOs to send their monthly subscription of GPF regularly each month to this Office. But even then it has been observed that still there are so many Officials/Officers of DA Cadre are sending their subscriptions late. Even few Officials/Officers are sending their subscriptions of two-three months in one go. As per Rule 11, bank drafts for subscription of GPF shall reach before the 5th day of the month. This Section is facing problem in posting the lumpsum subscriptions as the PFMS System does not allow posting of late Subscriptions.

It is, therefore, you are again requested to issue the strict instructions to the Officials/Officers of DA Cadre to send their GPF Subscriptions each month regularly before the 5th of every month.
