

Sub: Grant of Special Festival Allowance to Kerala State Service Pensioners/Family Pensioners for the year 2013-14

Government of Kerala, as per GO(P) No.367/2014/Fin dated 25.08.2014 have sanctioned Special Festival Allowance to Kerala State Service Pensioners/Family Pensioners at the rates mentioned below:

Category	Rate of Special Festival Allowance
Service pensioners	Rs.670
Family pensioners	Rs.550
Pro-rata pensioners	Rs.600
Pro-rata Family pensioners	Rs.600
Ex-gratia pensioners	Rs.550
Personal Staff Pensioners	Rs.550
Retired Leprosy Patient Employees	Rs.550
Part-time Contingent Pensioners	Rs.550
Part-time Contingent Family pensioners	Rs.480
Compassionate Allowance pensioners	Rs.480

This allowance is admissible to those pensioners in respect of whom:

- 1. Pension commenced from a date prior to 1.4.2013 and
- 2. Pension commenced after 1.4.2013 but is not eligible for bonus or such other allowances as per the above Government Order for want of 6 months continuous service during the financial year 2013-2014. In their case, a self declaration to the effect that they are not eligible for bonus or special festival allowance by virtue of their service during 2013-14 may be insisted upon before arranging payment.

The allowance sanctioned as per these orders shall be disbursed to the eligible Pensioners/Family Pensioners before 31.3.2015.

If a Service Pensioner is also in receipt of family pension, the special festival allowance is payable only on the basis of one of those pensions.

The special festival allowance sanctioned as per these orders is admissible to all State Pensioners/Fal. ly Pensioners except to the following categories.

- 1. All India Pensioners/Family Pensioners
- 2. Re-employed pensioners
- 3. Employed Family Pensioners
