Certificate of the Comptroller and Auditor General of India

This compilation containing the Finance Accounts of the Government of Arunachal Pradesh for the year ending 31st March 2014 presents the financial position along with accounts of the receipts and disbursements of the Government for the year. These accounts are presented in two volumes, Volume-I contains the consolidated position of the state of finances and Volume – II depicts the accounts in detail. The Appropriation Accounts of the Government for the year for Grants and Charged Appropriations are presented in a separate compilation.

The Finance Accounts have been prepared under my supervision in accordance with the requirements of the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971 and have been compiled from the vouchers, challans and initial and subsidiary accounts rendered by the treasuries, offices and departments responsible for the keeping of such accounts functioning under the control of the Government of Arunachal Pradesh and the statements received from the Reserve Bank of India. Statements (Nos. 8 and 9), explanatory notes (Statement No. 11 and Statement No. 12) and appendices (IV, V, IX and X) in this compilation have been prepared directly from the information received from the Government of Arunachal Pradesh/Corporations/ Companies/ Societies who are responsible to ensure the correctness of such information.

The treasuries, offices and/or departments functioning under the control of the Government of Arunachal Pradesh are primarily responsible for preparation and correctness of the initial and subsidiary accounts as well as ensuring the regularity of transactions in accordance with the applicable laws, standards, rules and regulations relating to such accounts and transactions. I am responsible for preparation and submission of Annual Accounts to the State Legislature. My responsibility for the preparation of accounts is discharged through the office of the Accountant General Arunachal Pradesh. The audit of these accounts is independently conducted through the office of the Accountant General, Arunachal Pradesh in accordance with the requirements of Articles 149 and 151 of the Constitution of India and the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971, for expressing an opinion on these Accounts based on the results of such audit. These offices are independent organizations with distinct cadres, separate reporting lines and management structure.

The audit was conducted in accordance with the Auditing Standards generally accepted in India. These Standards require that we plan and perform the audit to obtain reasonable assurance that the accounts are free from material misstatement. An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the financial statements.

On the basis of the information and explanations that my officers required and have obtained, and according to the best of my information as a result of test audit of the accounts and on consideration of explanations given, I certify that, to the best of my knowledge and belief, the Finance Accounts read with the explanatory ‘Notes to Accounts’ give a true and fair view of the financial position, and the receipts and disbursements of the Government of Arunachal Pradesh for the year 2013-14.

Points of interest arising from study of these accounts as well as test audit conducted during the year or earlier years are contained in my Reports on the Government of Arunachal Pradesh being presented separately for the year ended 31st March 2014.

Guide to the Finance Accounts

A. Broad overview of the structure of Government accounts

1. The Finance Accounts of the State of Arunachal Pradesh present the accounts of receipts and outgoings of the Government for the year, together with the financial results disclosed by the Revenue and Capital accounts, the accounts of the Public Debt and the liabilities and assets of the State Government as worked out from the balances recorded in the accounts.

2. The Accounts of the Government are kept in three parts:

Part I: The Consolidated Fund: This Fund comprises all revenues received by the State Government, all loans raised by the State Government (market loans, bonds, loans from the Central Government, loans from Financial Institutions, Special Securities issued to National Small Savings Fund, etc.), Ways and Means advances extended by the Reserve Bank of India and all moneys received by the State Government in repayment of loans. No moneys can be appropriated from this Fund except in accordance with law and for the purposes and in the manner provided by the Constitution of India. Certain categories of expenditure (e.g., salaries of Constitutional authorities, loan repayments etc.), constitute a charge on the Consolidated Fund of the State (Charged expenditure) and are not subject to vote by the Legislature. All other expenditure (Voted expenditure) is voted by the Legislature.

The Consolidated Fund comprises two sections: Revenue and Capital (including Public Debt, Loans and Advances). These are further categorised under ‘Receipts’ and ‘Expenditure’. The Revenue Receipts section is divided into three sectors, viz., ‘Tax Revenue’, ‘Non Tax Revenue’ and ‘Grants in Aid and Contributions’. These three sectors are further divided into sub-sectors like ‘Taxes on Income and Expenditure’, ‘Fiscal Services’, etc. The Capital Receipts section does not contain any sectors or sub-sectors. The Revenue Expenditure section is divided into four sectors, viz., ‘General Services’, ‘Social Services’, ‘Economic Services’ and ‘Grants in Aid and Contributions’. These sectors in the Revenue Expenditure section are further divided into sub-sectors like, ‘Organs of State’, ‘Education, Sports, Art and Culture’ etc. The Capital Expenditure section is sub-divided into seven sectors, viz., ‘General Services’, ‘Social Services’, ‘Economic Services’, ‘Public Debt’, ‘Loans and Advances’, ‘Inter-State Settlement’ and ‘Transfer to Contingency Fund’.

Part II: The Contingency Fund: This Fund is in the nature of an imprest which is established by the State Legislature by law, and is placed at the disposal of the Governor to enable advances to be made for meeting unforeseen expenditure pending authorisation of such expenditure by the State Legislature. The fund is recouped by debiting the expenditure to the concerned functional major head relating to the Consolidated Fund of the State. The Contingency Fund of the Government of Arunachal Pradesh for 2013-14 is ₹ 0.05 crore.

Part III: The Public Account: All other public moneys received by or on behalf of the Government, where the Government acts as a banker or trustee, are credited to the Public Account. The Public Account includes repayables like Small Savings and Provident Funds, Deposits (bearing interest and not bearing interest), Advances, Reserve Funds (bearing interest and not bearing interest), Remittances and Suspense heads (both of which are transitory heads, pending final booking). The net cash balance available with the Government is also included under the Public Account. The Public Account comprises six sectors, viz., ‘Small Savings, Provident Funds etc.’, ‘Reserve Funds’, ‘Deposit and Advances’, ‘Suspense and Miscellaneous’, ‘Remittances’,

and ‘Cash Balance’. These sectors are further sub-divided into sub-sectors. The Public Account is not subject to the vote of the Legislature.

3. Government accounts are presented under a six tier classification, viz., Major Heads (four digits), Sub-Major Heads (two digits), Minor Heads (three digits), Sub-Heads (two characters), Detailed Heads (two to three digits), and Object Heads (two or three digits). Major Heads represent functions of Government, Sub- Major Heads represent sub-functions, Minor Heads represent programmes/ activities, Sub-Heads represent schemes, Detailed Heads represent sub-schemes, and Object Heads represent purpose/ object of expenditure.

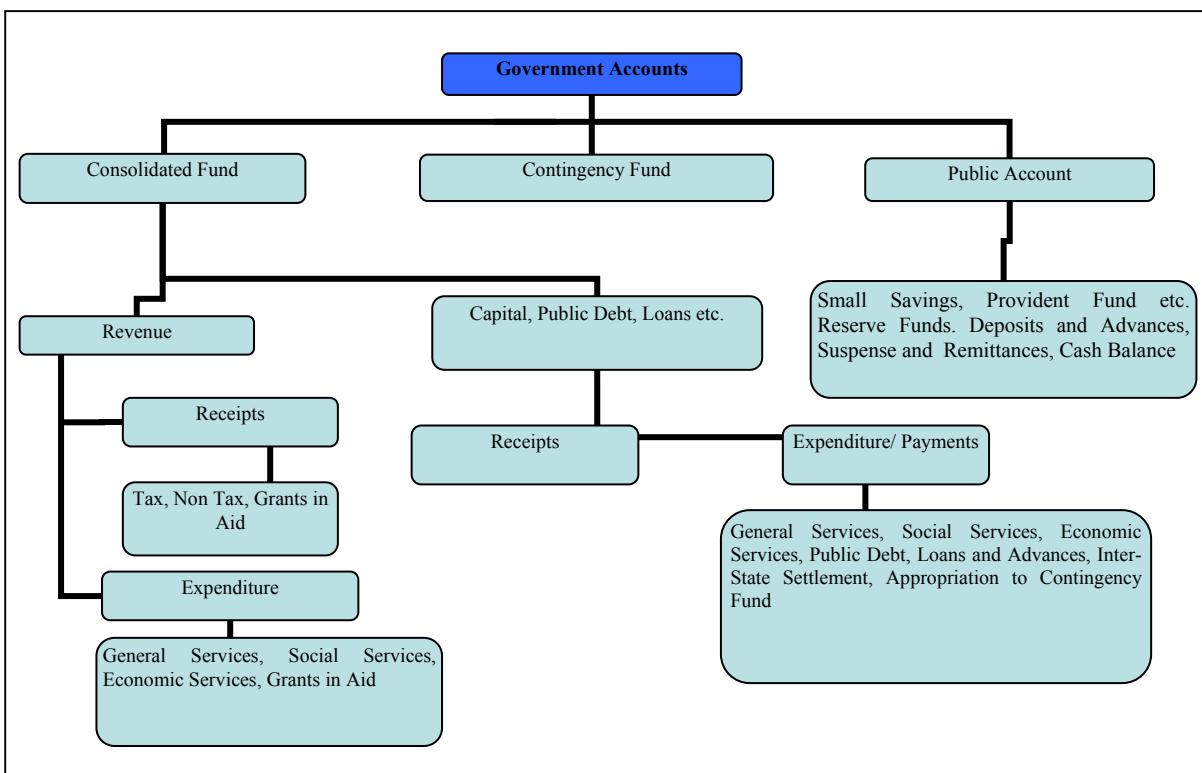
4. The main unit of classification in accounts is the Major Head which contains the following coding pattern (according to the List of Major and Minor Heads corrected upto March 2014)

0020 to 1606	Revenue Receipts
2011 to 3606	Revenue Expenditure
4000	Capital Receipts
4046 to 7810	Capital Expenditure (including Public Debt, Loans and Advances)
7999	Appropriation to the Contingency Fund
8000	Contingency Fund
8001 to 8999	Public Account

5. The Finance Accounts, generally (with some exceptions), depict transactions upto the Minor Head. The figures in the Finance Accounts are depicted at net level, i.e., after accounting for recoveries as reduction of expenditure. This treatment is different from the depiction in the Demands for Grants presented to the Legislature and in the Appropriation Accounts, where, expenditure is depicted at the gross level.

6. A pictorial representation of the structure of accounts is given below:

B. What the Finance Accounts contain

The Finance Accounts are presented in two volumes.

Volume-I contains the Certificate of the Comptroller and Auditor General of India, the Guide to the Finance Accounts, four statements which give summarised information on the financial position and transactions of the State Government for the current financial year, Notes to Accounts and an appendix to the Notes to accounts. Details of the **four** statements in **Volume-I** are given below:

1. **Statement of Financial Position:** This statement depicts the cumulative figures of assets and liabilities of the State Government, as they stand at the end of the year, and as compared to the position at the end of the previous year.
2. **Statement of Receipts and Disbursements:** This statement depicts all receipts and disbursements of the State Government during the year in all the three parts in which Government accounts are kept, viz., the Consolidated Fund, Contingency Fund and Public Account. In addition, it contains an annexure, showing alternative depiction of Cash Balances (including investments) of the Government. The Annexure also depicts the Ways and Means position of the Government in detail.
3. **Statement of Receipts (Consolidated Fund):** This statement comprises revenue and capital receipts (including disinvestments, borrowings and recoveries of loans and advances). This statement corresponds to detailed statements 11, 15 and 16 in Volume-II of the Finance Accounts.
4. **Statement of Expenditure (Consolidated Fund):** In departure from the general depiction of the Finance Accounts up to the Minor Head level, this statement gives details of expenditure by nature of activity (objects of expenditure) also. This statement corresponds to detailed statement 12, 13 and 16 in Volume-II.

Volume-II of the Finance Accounts contains **three parts- six summary statements in Part I, nine detailed statement in Part II and twelve Appendices in Part III.**

Part I of Volume-II

5. **Statement of Progressive Capital Expenditure.** This statement corresponds to the detailed statement 13 in Part II.
6. **Statement of Borrowings and Other Liabilities:** Borrowings of the Government comprise market loans raised by it (Internal Debt) and Loans and Advances received from the Government of India. ‘Other Liabilities’ comprise ‘Small Savings, Provident Funds etc.’, ‘Reserve Funds’ and ‘Deposits’. The statement also contains a note on service of debt, and corresponds to the detailed Statement 15 in Part II.

7. Statement of Loans and Advances given by the Government: This statement depicts all loans and advances given by the State Government to various categories of loanees like Statutory Corporations, Government Companies, Autonomous and Other Bodies/ Authorities and recipient individuals (including Government servants). This statement corresponds to the detailed statement 16 in Part II.

8. Statement of Grants in Aid given by the Government: This statement depicts all Grants in Aid given by the State Government to various categories of grantees like Statutory Corporations, Government Companies, Autonomous and Other Bodies/ Authorities and individuals. Appendix IV provides details of the recipient institutions.

9. Statement of Guarantees given by the Government: This statement summarises the guarantees given by the State Government on repayment of principal and interest on loans raised by Statutory Corporations, Government Companies, Local Bodies and Other institutions.

10. Statement of Voted and Charged Expenditure: This statement assists in the agreement of the net figures appearing in the Finance Accounts with the gross figures appearing in the Appropriation Accounts.

Part II of Volume- II

11. Detailed Statement of Revenue and Capital Receipts by Minor Heads: This statement corresponds to the summary statement 3 in Volume-I of the Finance Accounts.

12. Detailed Statement of Revenue Expenditure by Minor Heads: This statement, which corresponds to the summary statement 4 in Volume-I, depicts the revenue expenditure of the State Government under Plan (State Plan, Centrally Sponsored Schemes and Central Plan Schemes) and Non Plan. Charged and Voted expenditure are exhibited distinctly.

13. Detailed Statement of Capital Expenditure by Minor Heads and Subheads: This statement, which corresponds to the summary statement 5 in Part-I of this volume, depicts the capital expenditure (during the year and cumulatively) of the State Government under Plan (State Plan, Centrally Sponsored Schemes and Central Plan Schemes) and Non Plan. Charged and Voted expenditure are exhibited distinctly. In addition to representing details of capital expenditure at Minor Head level, in respect of significant schemes, this statement depicts details at Sub Head levels also.

14. Detailed Statement of Investments of the Government: This statement depicts investments of the State Government in the equity capital of Statutory Corporations, Government Companies, other Joint Stock Companies, Cooperative institutions and Local Bodies.

15. Detailed Statement of Borrowings and Other Liabilities by Minor Heads: This statement, which corresponds to the summary statement 6 in Part I of this volume, contains details of all loans raised by the State Government (market loans, bonds, loans from the Central Government, loans from Financial Institutions, Special Securities issued to National Small Savings Fund, etc.), and Ways and Means advances extended by the Reserve Bank of India. This statement presents the information on loans under three categories: (a) details of individual loans; (b) maturity profile, i.e. amounts payable in respect of each category of loans in different years; and (c) interest rate profile of outstanding loans.

16. Detailed Statement on Loans and Advances given by the Government: This statement corresponds to the summary statement 7 in Part I of this volume.

17. Statement on Sources and Application of Funds for Expenditure other than on Revenue Account: This statement is based on the principle that revenue expenditure is expected to be defrayed from revenue receipts, while capital expenditure of the year is met from revenue surplus, net credit balances in the public account, cash balance at the beginning of the year, and borrowings.

18. Detailed Statement on Contingency Fund and Other Public Account transactions: This statement depicts at Minor Head level the details of unrecouped amounts under Contingency Fund, consolidated position of Public Accounts transactions during the year, and outstanding balances at the end of the year.

19. Detailed Statement on Investment of Earmarked Balances: This statement depicts details of investments from the Reserve Funds and Deposits (Public Account).

Part III of Volume-II

Part III contains twelve appendices on various items including salaries, subsidies, grants-in-aid, externally aided projects, scheme wise expenditure in respect of major Central schemes and State Plan schemes, etc. These details are present in the accounts at Sub head level or below (i.e. below Minor Head levels) and so are not generally depicted in the Finance accounts. A detailed list of appendices appears at the 'Index' in Volume-I or Volume-II. The statements read with the appendices give a complete picture of the state of finances of the State Government.

D. Periodical adjustments and Book adjustments:

Certain transactions that appear in the accounts do not involve actual movement of cash at the time of booking. Some of these transactions take place at the level of the account rendering units (e.g. treasuries, divisions etc.) themselves. For instance, transactions involving adjustment of all deductions (GPF, recoveries of advances given etc.) from salaries are recorded by debiting functional major heads (pertaining to the concerned department) by book adjustment to revenue/*loans/public* account receipts. Similarly ‘nil’ bills where moneys transferred between the Consolidated Fund and Public Account represent non-cash transactions occurring at the level of the accounts rendering units.

In addition of the above the Principal Accountant General/Accountant General (A&E) carries out *periodical* adjustments and book adjustments of the following nature in the accounts of the State Government, details of which appear in Appendix-I (Volume-I) and footnotes to the relevant statements.

Examples of periodical adjustments and book adjustments are given below:

- (1) Creation of funds/ adjustment of contribution to Funds in Public Account by debit to Consolidated Fund e.g., *State Disaster Response Fund, Central Road Fund, Sinking Fund, etc.*

(2) Crediting of deposit heads of accounts in Public Account by debit to Consolidated Fund.

(3) Annual adjustment of interest on General Provident Fund GPF and State Government Group Insurance Scheme where interest on GPF is adjusted by debiting Major Head 2049-Interest and crediting Major Head 8009-General Provident Fund.

(4) Adjustment of Debt waiver under the scheme of Government of India based on the recommendations of the Central Finance Commissions. These adjustments (where Central loans are written off by crediting Major Head 0075-Misc. General Services by contra entry in the Major Head 6004-Loans and Advances from the Central Government) impact both Revenue Receipts and Public Debt heads.

NOTES TO ACCOUNTS

1. Summary of Significant Accounting Policies

(i) Entity and Accounting Period

These accounts present the transaction of the Government of Arunachal Pradesh for the period 1 April 2013 to 31 March 2014 and have been compiled based on the initial accounts rendered by the 17 District Treasuries, 154 Public Works and 46 Forest Divisions of the State Government and Advices of the Reserve Bank of India. The average delay in rendition of monthly accounts was 46 days by Treasuries, 46 days by Public Works Divisions and 35 days by Forest Divisions. However, no accounts have been excluded at the end of the year.

(ii) Basis of Accounting

With the exception of some book adjustments (**Appendix1-A**), the accounts represent the actual cash receipts and disbursements during the accounting period. Physical Assets and Financial Assets such as investments are shown at historical cost, i.e., the value at the year of acquisition/purchase. Physical assets are not depreciated or amortized. Losses in physical assets at the end of their life have not been expensed or recognized.

(iii) Currency in which Accounts are kept

The accounts of the Government of Arunachal Pradesh are maintained in Indian Rupees.

(iv) Form of Accounts

Under Article 150 of the Constitution of India, the accounts of the Union and States are kept in such form as the President may, on the advice of the Comptroller and Auditor General of India, prescribe. The word “form” used in Article 150 has a comprehensive meaning so as to include the prescription not only of the broad form in which the accounts are to be kept but also the basis for selecting appropriate heads under which the transactions are to be classified.

(v) Classification between Revenue and Capital

Revenue Expenditure is recurring in nature and is intended to be met from revenue receipts. Capital Expenditure is defined as expenditure incurred with the object of increasing concrete assets of a material and permanent character or of reducing permanent liabilities. As per the Indian Government Accounting Standards (IGAS) 2, expenditure on Grants-in-Aid is to be classified as Revenue expenditure regardless of end utilization. However, during the year, the Government incorrectly made budget provision and incurred an amount of ₹ 10.03 crore on ‘Grants-in-Aid’ under Capital Major Heads, instead of under the Revenue Section.

Notes to Accounts (*contd.*)

Consequently, the Revenue Surplus of the State Government for the year 2013-14 was overstated to that extent. Further, the Government of Arunachal Pradesh could not furnish the total value, if any, of Grants-in-Aid paid in kind during the year. Consequently, the information contained in Section (ii) of Statement No: 8 - Grants-in-Aid is incomplete.

2. Quality of Accounts

(i) Booking under Minor Head “800 -Other Receipts and Other Expenditure”

Minor Head 800 – ‘Other Receipts’/‘Other Expenditure’ are intended to be operated only when the appropriate Minor Head under the Major Head has not been provided in the accounts. Routine operation of Minor Head 800 is to be discouraged, since it renders the accounts opaque. During 2013-2014, an amount of ₹ 12,91.52 crore under 33 Revenue Receipt Major Heads of accounts, constituting 15.16 *per cent* of the total Revenue of ₹ 58,20.43 crore, was recorded under the Minor Head 800 – ‘Other Receipts’. Similarly, ₹ 23.87.83 crore under 80 Revenue and Capital Expenditure Major Heads of accounts, constituting 32.22 *per cent* of the total expenditure of ₹ 7,411.10 crore (Revenue and Capital) was recorded under the Minor Head 800 – ‘Other Expenditure’ below the concerned Major Heads. Instances of substantial proportion (50 *per cent* and above) of bookings made under Minor Head 800 – Other Receipts/Expenditure are given in **Appendices1-B and1-C** respectively.

(ii) Unadjusted Abstract Contingency (AC) Bills

Drawing and Disbursing Officers are authorized to draw sums of money by preparing Abstract Contingency (AC) Bills by debiting service heads. They are required to present Detailed Countersigned Contingency (DCC) Bills containing vouchers in support of final expenditure within one month of the drawal of AC Bills to the Accountant General. As on 31 March 2014, DCC Bills for 451 AC Bills, amounting to ₹ 10.71 crore, were not received. Prolonged non-submission of DCC Bills renders the expenditure under AC Bills opaque. Details are given below:

Out of ₹ 15.66 crore drawn against AC Bills in 2014, AC bills amounting to ₹ 10.34 crore were drawn in March 2014 alone, out of which ₹ 2.15 crore was drawn on the last day of the financial year. Significant expenditure against AC Bills at the fag end of the year indicates that the drawal was primarily to exhaust the Budget and reveals inadequate budgetary control.

(iii) Reconciliation of Receipts and Expenditure

All Controlling Officers are required to reconcile the Receipts and Expenditure recorded in their books every month during the financial year with figures accounted for by the Accountant General. This exercise facilitates effective control over expenditure to keep it within the budget and ensure accuracy of their accounts, during 2013-14, receipts amounting to ₹ 5197.66 crore (89.30 *per cent* of total receipts) and expenditure of ₹ 75,98.71 crore (100 *per cent* of expenditure) was reconciled by the State Government. Partial reconciliation of receipts affects the completeness and accuracy of accounts.

(iv) Reconciliation of Cash Balance

There was a net difference of ₹ 8.78 crore (Credit) at the end of the accounting year 2013-14 between the Cash Balance in the books of the Accountant General and figures reported by the Reserve Bank of India. Details are given in the Note below Annexure to Statement 2 of Finance Accounts (Volume-I). This difference is mainly due to erroneous reporting by the accredited banks to the Reserve Bank of India, Nagpur, which is responsible for maintaining the Cash Balance of the State Government. Such differences need to be reconciled by Treasuries of the Government of Arunachal Pradesh with the accredited banks.

(v) Outstanding Utilization Certificates (UCs) against Grants-in-Aid sanctioned by the State Government

State Government authorities who sanction conditional grants are required to furnish formal Utilization Certificates (UCs) regarding proper utilization of the Grant, from administrative, technical and financial points of view to the Accountant General. Such UCs are normally due within one year from the date of sanction, unless otherwise mentioned in the Sanction Order. Detailed review of outstanding UCs depicted in the accounts indicates that none of these UCs require to be watched by the Accountant General.

Notes to Accounts (*contd.*)**(vi) Transfer of Funds to Personal Deposit (PD) Accounts**

The State Government is authorized to open Personal Deposit (PD) Accounts to deposit funds required for specific purposes by transfer of funds from the Consolidated Fund. Transfers of funds to PD Accounts are booked as expenditure from the Consolidated Fund under concerned service Major Heads without any actual cash flow. PD Accounts are normally required to be closed on the last working day of the year and unspent balances transferred back to the Consolidated Fund.

The Government of Arunachal Pradesh follows the Central Treasury Rules. In terms of the Central Treasury Rules (647 and 648), PD Accounts remaining inoperative for two years are required to be closed. However, one PDA Account remained inoperative since 2007-08, two were inoperative since 2010-11 and two were inoperative since 2012-13. In addition, 9 District Treasuries had PD Accounts that were operated by the Director of Town Planning & Urban Development Department, District Animal Husbandry & Veterinary Department, Controller of Legal Metrology & Consumer Affairs, Regional Exotic Pig Breeding Farm, Director of Agriculture, Administrative Training Institute, etc.; and which were permanent in nature. Notes to Accounts (*contd.*)**(vii) Adverse Balances**

Accounts closing to balance should show either Credit or Debit balances, depending upon their nature; if they are otherwise (debit or credit balances as the case may be), such balances are considered ‘Adverse’. Adverse Balances under Loan Heads occur when recoveries are in excess of the amount of loan depicted as advanced. Similarly, Debit balances appearing under Deposit Heads indicate that disbursements are more than the amount deposited. Though adverse balances do not have any implications on the fiscal indicators of the Government, they indicate an inaccurate and inconsistent status, and distort the concerned Summarized and Detailed Statements in the Finance Accounts. Adverse Balances as at the end of 2013-14 were ₹ 1,92.26 crore (debit), as detailed below:

3. Other Items**(i) Liabilities on Retirement Benefits**

Expenditure on pension and other retirement benefits during 2013-14 to State Government employees recruited on or before 31st December 2007 was ₹ 3,98.40 crore (5.38 *per cent* of the total expenditure of ₹ 74,11.09 crore). State Government employees recruited on or after 1st January 2008 are covered under the New Pension Scheme (NPS), which is a defined contributory pension scheme. In terms of the Scheme, employees contribute 10 *per cent* of Basic Pay and Dearness Allowance, which is matched by the State Government, and the entire amount is to be transferred to the designated Fund Manager through the National Securities Depository Limited (NSDL)/Trustee Banks. The actual amount payable by the employees and matching Government contribution since inception of the scheme has not been estimated. Consequently, the actual liability of the employees and the Government under the Scheme is not known.

Notes to Accounts (*contd.*)

As per the accounting procedure followed by the State Government, the employees' and employer's contributions are directly debited to the departmental Major Head. Since the State Government does not operate Major Head 2071-117 as required, the accounts do not reveal the break-up between employees and employer's contributions. Cheques are prepared by the concerned departmental Drawing and Disbursing Officers (DDO) and remitted to the Director of Treasuries who books them to Government account, crediting Major Head '8342-117 Defined Contributory Pension Scheme'. During the year, the State Government deposited ₹ 24.11 crore to the fund under Major Head 8342-117. The deposited amount could not be transferred to Trustee Banks/Pension Fund Manager for want of Permanent Retirement Account Number (PRAN) from NSDL. As on 31 March 2014, ₹ 47.78 crore remained in the Public Account under Major Head 8342-117. In terms of the Guidelines of the scheme, Government of Arunachal Pradesh is liable to pay interest on contributions as applicable to General Provident Fund balances. However, Government has not paid any interest for 2013-14 and it has not been estimated whether interest has been paid in earlier years also. Uncollected, unmatched and untransferred amounts, with accrued interest, represent outstanding liabilities under the scheme.

(ii) Guarantees

Guarantees are contingent liabilities on the Consolidated Fund of the State, to provide for default by borrowers on whose loans guarantees were extended. As at the end of 2012-2013, the accounts of the State Government showed that guarantees of an amount of ₹ 1.55 crore were outstanding under the Arunachal Pradesh Industrial Development and Financial Corporation (APIDFC). The State Government has not furnished information on fresh guarantees given or details of guarantees invoked during the current year. Consequently, Statement 9, which is based on IGAS 2, notified by the Government of India, is incomplete. In terms of the Arunachal Pradesh Fiscal Responsibility & Budget Management (FRBM) Act, the State Government is required to include a statement on Guarantees given by the Government in the Medium Term Fiscal Policy Statement, laid along with Annual Budget documents in the State Legislature which, however, has not been done. The State Government has not passed any legislation laying down the maximum limit within which Guarantees may be given on the security of the Consolidated Fund of the State. The Government has also not constituted a Guarantee Redemption Fund.

Notes to Accounts (*contd.*)

(iii) Reserve Funds

(a) Consolidated Sinking Fund (CSF)

In January 2007, in terms of the recommendations of the Twelfth Finance Commission, the State Government constituted the ‘Consolidated Sinking Fund’ for amortization of loans. According to Guidelines of the Reserve Bank of India, which is responsible for management of the Fund, States are required to contribute a minimum of 0.5 *per cent* of the outstanding liabilities (internal debt plus public account) as at the end of the previous year. During the year, the State Government contributed ₹ 20 crore against the requirement of ₹ 22.22 crore (0.5 *per cent* of the total outstanding liabilities of the Government of Arunachal Pradesh as on 31 March 2013, i.e., ₹ 44,43.05crore), which resulted in over-statement of Revenue Surplus and under-statement of Fiscal Deficit by ₹ 2.22 crore. As on 31 March 2014, an amount of ₹ 1,49.90 crore was lying in the Fund, and the total amount has been invested. Details of transactions in the Fund during 2013-14 are given in Statements 18 and 19 of the Finance Accounts (Volume – II).

(b) State Disaster Response Fund

Government of India replaced the existing Calamity Relief Fund in 2010-11 with the State Disaster Response Fund (SDRF). In terms of the Guidelines of the Fund, the Centre and Special category States like Arunachal Pradesh are required to contribute to the Fund in the proportion of 90:10. As per Guidelines, these contributions are to be transferred to the Public Account under Major Head 8121 by operating the Expenditure Major Head 2245. Expenditure incurred during the year on disaster response is adjusted by debiting the Public Account with contra deduct debit to the Expenditure Major Head 2245. Balances outstanding in the Fund, at the end of the year are invested. Government of India provides additional assistance from the National Disaster Response Fund (NDRF) – with no State Government share- when the balances available under SDRF are insufficient to meet the expenditure on account of natural calamities. The entire funds provided under the NDRF are incurred directly against the expenditure on natural calamities.

During 2013-14, the Central Government released an amount of ₹ 38.29 crore towards SDRF and ₹ 1,40.46 crore from NDRF. The State Government transferred the entire Central Government release together with its own share (₹ 4.25 crore) to the Fund. As on 31 March 2014, ₹ 44.54 crore remained in the Fund, which, however, has not been invested contrary to Guidelines.

Notes to Accounts (*contd.*)

(iv) Loans and Advances

Details of Loans and Advances made by the State Government are included in Annexure ‘A’ to Appendix–VIII of the Finance Accounts (Volume –II) in the format prescribed by the Indian Government Accounting Standards (IGAS) 3, notified by the Government of India. However, the information is incomplete, since detailed information on overdue Principal and Interest in respect of Loans and Advances where accounts are maintained by the State Government, is awaited. The State Government has also not confirmed the balances as on 31st March 2014, including those where individual loanee accounts are maintained by the Accountant General.

(v) Suspense and Remittance Balances

The Finance Accounts reflect net balances under Suspense and Remittance Heads as detailed in Statement 18 of the Finance Accounts (Volume-II). Outstanding balances under these heads are worked out by aggregating outstanding debit and credit balances separately under various heads. Clearance of suspense and remittance items depend on the details furnished by State Treasuries, Works/Forest Divisions, PAOs, etc;. Details of outstanding Suspense and Remittance balances are given in **Appendix1-D**.

(vi) Reserve Funds and Deposits bearing Interest

Interest liabilities in respect of Reserve Funds Bearing Interest and Deposits Bearing Interest under Sectors ‘J’ and ‘K’ respectively of the Public Accounts are annual liabilities that the State Government is required to discharge. No Budget provision has been made by the State Government despite balances in such Reserve Funds and Deposits as on 01 April 2013, as detailed below:

Non-provision of interest resulted in over-statement of Revenue Surplus and under-statement of Fiscal Deficits by ₹ 2.21 crore on the balances as on 1st April 2013.

Notes to Accounts (*contd.*)**(vii) Contingency Fund**

The Contingency Fund of the Government of Arunachal Pradesh is set up under Article 267(2) of the Constitution of India for meeting unforeseen expenditure and is recouped when the State Legislature authorizes the additional expenditure. The corpus of the Fund is ₹ 0.05 crore. No amount was drawn from the Contingency Fund during the year and there was no outstanding balance un-recouped as on 31 March 2014.

(viii) Shortfall in Expenditure on Central Schemes

The State Government is entrusted with the execution of Central Plans and Centrally Sponsored Schemes in the State, for which grants are released by the Government of India. In addition, the Government of India also releases fund under the State Plan and Special Plan Schemes. The State Government provides for the Central and State share in its Budget. During the year, the Government of India released ₹ 31,91.39 crore towards Central Plan/Centrally Sponsored Schemes, State Plan Schemes and Special Plan Schemes. Against this, the State Government spent ₹ 34,47.30 crore, including its own share. Due to inadequate mapping of Central schemes with those of the schemes of the State Government, the extent to which the State Government has fulfilled its liability towards contribution against Government of India releases is not ascertainable. Details of releases of Central share and State share in respect of major schemes are given in **Annexure to Statement No: 12**.

(ix) Write-off of Loans given by the Central Government to the Government of Arunachal Pradesh

In furtherance of the recommendations of the Thirteenth Finance Commission, Ministry of Finance, Government of India, in a series of Orders, all dated 29 February 2012, wrote off loans advanced to the State Government by various Ministries (except those advanced by the Ministry of Finance itself) as on 31 March 2010 towards Central Plan and Centrally Sponsored Schemes. The Ministry of Finance permitted the State Governments to adjust the excess repayments of principal and interest made from the effective date of the Order (31 March 2010) and its implementation against future repayments to the Ministry of Finance. In respect of the Government of Arunachal Pradesh, write-off figures reflected in the Finance Accounts do not match with the figures furnished by the Ministry. The matter has been taken up with the Ministry and State Government for reconciliation and reply is awaited.

Notes to Accounts (*contd.*)

(x) Rush of Expenditure: In terms of Rule 56(3) of The General Financial Rules, 2005 (adopted by the State Government), rush of expenditure particularly in the closing month of the financial year shall be regarded as breach of financial regularity and should be avoided. State Government Departments, however, withdrew ₹ 43,75.99 crore in March 2014 and ₹ 1,85.45 crore on the last working day of March 2014 (59.05 and 2.50 *per cent* respectively of the total expenditure). Treasury-wise details of significant transactions are given in **Appendix1-E**.

(xi) Committed Liabilities and Implications of Major Policy decisions on new services proposed in budget on the future cash flows

Appendix on Implications of Major Policy decisions on new services proposed in budget on the future cash flows and on Committed Liabilities as recommended by Twelfth Finance Commission, does not find place in the accounts for want of requisite information from the State Government.

(xi) Impact of incorrect booking and non-adjustment of interest liabilities on Fiscal Indicators

1 Internal Debt :- The Internal Debt of State Government comprises (i) Long Term Loans raised from open market (ii) Ways and Means Advances from the Reserve Bank of India (iii) Loans from the National Agricultural Credit Fund of the Reserve Bank of India and (iv) loans from autonomous bodies such as Life Insurance Corporation of India, etc. Further details are given in Statement No.15 and Annexure to Statement No.15.

2 Market loans bearing interest :- These comprises long term loans (which have a currency of more than 12 months) raised in open market. In 2013-14 three loans of ₹80.00 crore, ₹1,00.00 crore and ₹50.00 crore were raised from the market which bear interest at 9.77 percent , 9.30 percent and 9.45 percent per annum redeemable at par in 2024, 2023 and 2024 respectively.

3 Loans from Small Savings Fund :- Loans out of the collection in the 'Small Savings Schemes' and 'Public Provident Fund' in the Post offices are being shared between the State Government and the Central Government in the ratio of 3:1. A separate fund viz. 'National Small Savings Fund' was created in 1999-2000 for the purpose of release of loans out of Small Savings collections. The loans received during 2013-2014 amounted to ₹3,08.37 crore and ₹1,64.83 crore was repaid during the year. The balance outstanding at the end of the year was ₹12,68.44 crore which was 50.65 per cent of the total Public Debt of the State Government as on 31 March 2014.

4 Loans and Advances from Government of India :- During 2013-14 the State Government has not received any loan from Government of India and ₹27.73 crore were paid towards repayment of loans . Details of loans from Government of India are given in Annexure to Statement No.15

In addition the balances at the credit of earmarked and other funds as also certain deposits, to the extent to which they have not been invested but are merged with the general cash balance to the Government, also constitute the liability of Government. The amount of such liability at the end of March 2014 was ₹ 1030.59 crore as shown below (further details are given in Statement No. 18 and 19).

EXPLANATORY NOTES

(a)There was a difference between the figures reflected in the accounts and that intimated by the Reserve Bank of India regarding "Deposits with Reserve Bank" included in the Cash Balance. The discrepancy is under reconciliation.

B. Government Account : Under the system of book-keeping followed in Government accounts, the amount booked under revenue, capital and other transactions of Government the balances of which are not carried forward from year to year in the accounts, are closed to a single head called "Government Account". The balance under this head represents the cumulative result of all such transactions To this the balances under Public Debt, Loans and Advances, Small Savings, Provident Funds, Reserve Funds, Deposits and Advances, Suspense and Miscellaneous (Other than Miscellaneous Government Account), Remittances and Contingency Fund, etc. are added and the closing cash balance at the end of the year is to be worked out and proved.

The other headings in the summary take into account the balances under all accounts heads in Government books in regard to which Government has a liability to repay the money received or has a claim to recover the amounts paid and also heads of account opened in the books for adjustment of remittance transactions.

It must be understood that these balances can not be regarded as a complete record of the financial position of the Government as it does not take into account all the physical assets of the State, such as lands, buildings, communication, etc. nor any accrued dues or outstanding liabilities which are not brought to account under the cash basis of accounting followed by Government.
