Subject :- Payment of Lifetime Arrears of pension(Nomination)Rules- applicable for the pensioner/family pensioners of Non-Government Institutions

It is learnt from a letter received from the General Secretary, West Bengal College & University Retired Teachers' Association that the Pension Disbursing Banks are refusing to accept the nomination form prescribed under Payment of Lifetime Arrears of Pension (Nomination)Rules,1986 causing unnecessary delay/harassment in payment of lifetime arrears of pension after demise of the pensioner/family pensioner.

In this connection it is informed that Rules ibid introduced by the Government of West Bengal, Finance Department, Audit Branch in their Notification No. 10885-F dated 24/10/85 read with Notification No. 1633-F dated 17/2/89 has been extended to all categories of pensioners/family pensioners of Non-Government Educational Institutions (which includes Non-Government School/College Teacher as well as Non-teaching staff retired from such Institutions) under Memo No.6725-F dated 7/7/90.

Accordingly all Pension Disbursing Officers are requested to make necessary arrangements for obtaining the Nomination form prescribed under the Rules ibid from each of pensioner/family pensioners of the Government of West Bengal (including pensioners/family pensioners of the Non-Govt. Educational Institutions) under their payment control, if not already furnished, and kept on record as provided under the Rules so that after death of the pensioner/family pensioner, the life time arrears of pension may be paid to his/her nominee(s) without any delay.
