**Sub:-Regarding "Designation" of Non-Govt. College Teachers who retired/died during the period from 1.4.78 to 31.12.95**


It has been reported by different Pension Disbursing Authorities as well as the pensioners/family pensioners in respect of Non-Govt. College Teachers, retired/died in harness during the period from 1.4.78 to 31.12.95, that while extending the benefit of revised pensionary benefits in terms of G.O. No.672-Edn(CS) dated 24.8.2010 read with 891-Edn(CS) dated 19.11.2010 (circulated vide this office circular No. Pen.Co-ordn/312/190 dated 8.12.2010), the Disbursing Authorities are facing difficulties in confirming the correct designation of the incumbents, at the time of their retirement, from the respective P.P.O.s.

Scrutiny reveals that this has occurred due to re-designation of the post of Lecturer as Sr.Scale Lecturer, Selection Grade Lecturer/Reader in terms of G.O. No.1287-Edn (CS) dated 21.9.88, consequent upon extension of the benefit of revised UGC scale, retrospectively with effect from 1.1.86.

In order to remove such anomaly, Education Directorate in their Memo. No.ED-40/2011 dated 10.2.2011 has set the modus operandi of ascertaining the correct designation from any of the following documents:-

- i) Copy of Statement of conversion of post approved by the Director of Public Instruction (DPI), West Bengal
- ii) Copy of the pay fixation Memos of the concerned Teachers

Accordingly, all Pension Disbursing Officers are requested to obtain any copy of the above mentioned documents duly attested by the concerned Authority for making payment of revised rates of pension in terms of this office circular dated 8.12.2010 to the concerned retired/died-in harness Lecturer, whose designation is subsequently converted as Sr.Scale Lecturer or Selection Grade Lecturer/Reader consequent upon introduction of revised UGC scale w.e.f. 1.1.86.
