No. Pen-162/2015 In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Orissa Civil Services (Commutation of Pension) Rules, 1992, namely:-

- These rules may be called the Odisha Civil Services (Commutation of Pension) Amendment Rules, 2015,
 - (2) They shall be deemed to have come into force on the date indicated against each of the amended rule and where no such indication has been made, the relevant amendments shall be effective from the date of their publication in the Odisha Gazette.
- 2. In the Odisha Civil Services (Commutation of Pension) Rules, 1992 (herein after referred to as the said rules after clause (g) of rule 3, the following clause shall be inserted namely:-
 - "(gg) "Odisha Civil Services (Pension) Form" means the form appended to the Odisha Civil Services (Pension) Rules, 1992;"
- 3. In the said rules, for sub-rule (1) of rule 5 the following sub-rule shall be substituted namely:-
- (1) A Government servant who retired after 01.12.2008 is entitled to commute for a lump sum payable a fraction not exceeding 40 per cent of his pension.

Provided that Judicial Officer who retired after 01.01.2006 is entitled to commute for a lump sum payable a fraction not exceeding 50 per cent of his pension.

Provided further that for the purpose of commutation of invalid pension, the amount of original invalid pension, determined with reference to qualifying years of service will only be taken into account.

- 4. In the said rules, after sub-rule (1) of rule 7 for the words "twelve years" the words "fifteen years" shall be substituted with effect from 01.12.2008.
- 5. In the said rules, after sub-rule (1) of rule 7 so substituted the following proviso shall be added namely:-

Provided that the Judicial Officer who retired after 01.01.2006 and have commuted a portion of their pension is entitled to have commuted portion of pension restored on expiry of fifteen years from the date of which the amount of pension was reduced on account of commutation of portion thereof.

- In the said rules, in-sub-rule (1) of rule 8 for the word and figure "Form-5" the 6. expression "Odisha Civil Services (Pension) Form C" shall be substituted.
- In the said rules, in sub-rule (2) of rule 5, in clause (i) of sub-rule 1 of rule 6, in the 7. proviso to rule 11, in clause (a) and (b) of sub-rule (1) and sub-rule (2) of rule 12, in sub-rule (1) and (2) of rule 13, in sub-rule (1) of rule 14 and in sub-rule (1) and (2) of rule 15, for the word and figure "Form 1", the expression "Odisha Civil Services (Pension) Form E" shall be substituted.
- In the said rules, in clause (a) of sub-rule (2) of rule 15, for the word and figure 8. "Form 6", the word and expression "Odisha Civil Services (Pension) Form N" shall be substituted.
