Subject: Grant of dearness relief to the pensioners of D.A. Getting Institutions with effect from 01.12.2009, 01.4.2010 and 01.12.2010.

In continuation to this Office Circular No. Pen. Co-ordn/111/Vol-V/121 dated 26.11.2009, it is stated that Govt. of West Bengal, School Education Department, Budget Branch in their order No. 457-SE(B), dated 28.12.2011 have sanctioned dearness relief @ 110%, @ 115% and @ 123% of basic pension w.e.f 01.12.2009, 01/4/2010 and 01/12/2010 respectively to the pensioners (both teaching and non-teaching employees) of D.A. getting schools who are drawing pension on the basis of pay scale under ROPA Rules upto 1998.

Accordingly, all Pension Disbursing Authorities are requested to make necessary arrangement for payment of dearness relief on pension to the above category of pensioners (who are drawing pension on the basis of pay scale under ROPA Rules upto1998.) @ 110%, @ 115% and @ 123% of basic pension with effect from 01.12.2009, 01/04/2010 and 01/12/2010 respectively on their pension only after proper adjustments.

In this connection, it is informed that this order is not applicable for the pensioners whose pension will be regulated on the basis of Pay Scales under ROPA Rules, 2009.

Payment of dearness relief on pension/family pension involving a fraction of rupee shall be rounded off to the next higher rupee.

Other provisions relating to grant of dearness relief on pension, as applicable to State Govt. pensioners, will also apply mutatis mutandis.
