This office letter no. P-I/Gen-3A/2011-12/1385-1452 dt. 28.8.2011.

I am to invite a reference to this office letter referred above on subject cited and to state that Govt. of Haryana vide its notification no. ½(8)98-2FR-II (Part-VIII) dt. 10.6.2011 has clarified that NPA is not to be taken into account while fixing the pension of the retiree (pre 01/01/2006 retd) based on minimum of pay in the pay scale+grade pay.

The instructions of this notification stated above may please be issued to all the pension disbursing authorities under your control under intimation to this office.
