Subject: - Grant of Dearness Relief to State Government Pensioners/Family
Pensioners-Revised rate effective from 01/01/2012.

In pursuance to the Ministry of Personnel, Public Grievances & Pensions, Govt. of India's OM No F. 42/13/2012-P&PW(G)dated 4<sup>th</sup> April, 2012 on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to decide that the Dearness Relief (DR) payable to the State Government Pensioners/Family Pensioners shall be enhanced from the existing rate of 58% to 65% with effect from 01-01-2012. The arrear for the period from the month of January 2012 to June 2012 be drawn and paid in cash during the month of July'2012 and thereafter may be paid every month in cash as usual.

All others terms and conditions as enunciated in Ministry of Personnel, Rublic Grievances and Pensions, Department of Pension and Pensioners Welfare, Govt. of India's aforesaid OM shall remain unchanged.
