In pursuance to the Ministry of Personnel, Public Grievances & Pensions, Govt. of India's OM No F.No.42/13/2012-P & PW(G) dated 2nd May'2013, on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to decide that the Dearness Relief (DR) payable to the **State Government Pensioners/ Family** Pensioners shall be enhanced from the existing rate of 72% to 80% with effect from 01-01-2013.

All others terms and conditions as enunciated in Ministry of Personnel, Public Grievances and Pensions, Department of Pension and Pensioners Welfare, Govt. of India's aforesaid OM shall remain unchanged.
