Subject: - Payment of arrears on account of revision of 1/3rd commuted portion of pension to those Govt. servants who had absorbed in PSUs/Autonomous Bodies.

In continuation to this Department's Office Memorandum of even number dated the 29th March, 2010 and 2nd November, 2010 on the subject cited above, the undersigned is directed to say that the Governor, Himachal Pradesh, is now pleased to order the payment of additional 20% of 1/3rd commuted portion of pension arrears upto 30-09-2009 accrued to the Pensioners (absorbees) w.e.f. 1.1.2006 or from the date of restoration of 1/3rd commuted portion of pension whichever, is latter to such Pensioners (absorbees). Thus, the total cumulative arrears released so far after taking into account the present release, shall amount to 40% of the total arrears to those Govt. servants who had been absorbed in PSUs/Autonomous Bodies.

2. It shall be the responsibility of Pension Disbursing Authorities including Public Sector Banks that 20% of 1/3rd commuted

portion of arrears as stated in para 1 above, is drawn and disbursed to the pensioners by 15th March, 2011 by all means.

3. In the case of Pensioners (absorbees), who have unfortunately died, the entire outstanding amount of arrears on account of 1/3rd commuted portion of pension shall be paid in cash to the family/legal heir(s)/Nominee(s) as the case may be within one month.
