Grant of revised Temporary Increase (Dearness Relief) to State Government Pensioners/ Family Pensioners with effect from dated: 01/1/2016

RESOLUTION:

The Government has decided to pay 119 % temporary increase (Dearness Relief) to State Government Pensioners/ Family Pensioners vide GR, FD NO.-HGV-1009-512-(O-1115/ 2015)-P Dated: 20-10-2015 Government has decided to increase the rates of temporary increase (Dearness Relief) admissible to State Government Pensioners/ Family Pensioners with effect from dated 01-01-2016 as under.

Admissible from date	Admissible Rate
01.1.2016	125 % of Basic Pension

1. Payment of Temporary Increase (Dearness Relief) involving a fraction of a rupee shall be rounded off to the next higher rupee.

2. Temporary Increase (Dearness Relief) at the rates indicated in above table will also be admissible on the additional basic pension/additional family pension available to Pensioners/Family Pensioners based on their age as indicated in Government Resolution, Finance Department, No. PGR-1009-4-Pay Cell (M), dated 13th April, 2009 and Government Resolution, Finance Department No. PGR-1009-5-Pay Cell (M), dated 13th April 2009.

3. The amount of revised Temporary increase with effect from dated: 01-1-2016 to the State Govt. Pensioners/Family Pensioners will be paid in cash.

4. It will be the responsibility of the Pension Disbursing Authority, to calculate

the quantum of Dearness Relief payable in each individual case.

5. All Accountant General of the respective States/Central Administrative Authority except Gujarat State are requested to take necessary action to authorize all the disbursing authorities under their control for making payment to Gujarat Pensioners drawing pensioners from their State Treasuries, Including Public Sector Banks.

6. Other Provisions governing grant of temporary Increase (Dearness Relief) to Pensioners such as regulations of dearness relief during employment/re-employment, regulations to temporary increase (Dearness Relief), where more than one pension is drawn etc. will remain unchanged.
