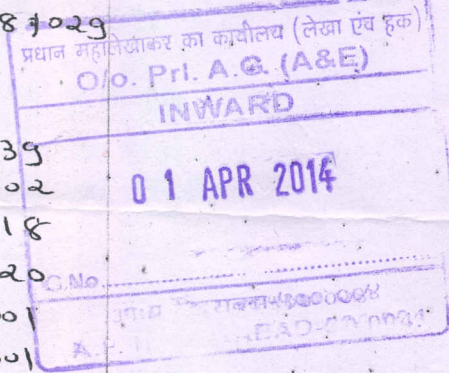

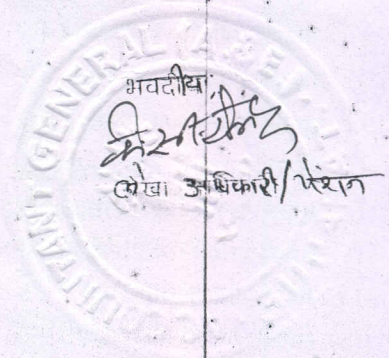

RESOLUTION :

The pensioners / family pensioners who are getting pension / family pension according to Pay Scales of Gujarat State Service (Revision of Pay), Rules, 1998 (5th Pay Commission) have been accorded temporary increase (T.I.) up to 166 % vide Govt. Resolution No. HGV-2008-500-(O-1090/2013)-P, dated 18th October, 2013 read at No. (ii) Above.

2. Temporary Increase up to 17 % has been accorded to the pensioners who are getting pension/family pension under Fifth Pay Commission as per the provision of Govt. of India, Office Memorandum dated : 17th October, 2013 read at No (iii) above. Accordingly, the Government of Gujarat has also decided to sanction temporary increase (T.I.) with effect from 01.07.2013 to the pensioners/family pensioners who are getting pension as per Fifth Pay Commission as under:

Admissible from date	Admissible Rate
01.07.2013	183 % of Basic Pension / Family Pension

3. The Temporary Increase will be admissible on the amount of basic pension/ family pension plus 50% of merged Dearness Relief as per the Govt. Resolution dated 01-09-2005.

4. These Orders shall be applicable to Parvashi Pensioners and Jivai Pensioners also.

5. The amount payable as Temporary Increase shall be rounded off to the next rupee but an amount of less than 50 paise shall not be paid.


6. The arrears of difference payable under these Orders shall be paid in cash from dt. : 01.07.2013.

7. Other terms and conditions in the Govt. Resolutions read above shall be applicable to the pensioners./family pensioners for the Temporary Increase.

8. Accountant Generals of all the other States except Gujarat are requested to authorize concerned Disbursing Officers (including Public Sector Banks) under their control to make the payment as per these Orders to the Pensioners who are getting pension from their State.
