Revision of provisions regulating pension /gratuity / commutation of pension for pensioners / family pensioners of the subordinate judicial officers including labour court and industrial court in the State

PREAMBLE

In pursuance of the recommendations of Hon'ble Justice E.Padmanabhan Committee and orders issued by The Hon'ble Supreme Court Dated: 26.7.2010 & 02.08.2010 in I.A.244 in Writ Petition 1022(C) of 1989. The pension/family pension of pensioners/family pensioners of the subordinate judicial officers in the state was under consideration of the State Government. After careful consideration, the state government is pleased to accord sanction to the regulation of pension/family pension of pensioners/family pensioners of the subordinate judicial officers in the state in the following manners::-

RESOLUTION

1.1 Save as otherwise mentioned in this order, the revised provisions shall apply to pensioners/family pensioners of the subordinate judicial officers including presiding /Judicial officers of Industrial and Labour Courts.

- 1.2 Where pension/family pension/all kinds of gratuity/commutation of pension etc. have already been sanctioned in cases occurring on or after 01.01.2006, the same shall be revised in terms of this order. The pension already sanctioned shall not be revised to the disadvantage of the pensioners.
- 1.3 This order shall apply with effect from 01.01.2006.

Part-I:- REVISION of PENSION IN RESPECT OF THE JUDICIAL OFFICER WHO RETIRED /Retires On and AFTER 01.01.2006.

- (1)Commutation of Pension :- A retired judicial officer shall continue to allow commutation of pension up to maximum of 50% of the pension.
- (2)Qualifying Service: Qualifying years of service of Judicial Officer for earning full pension shall be 20 years and for earning minimum pension shall be 10 years.
- (3) Pay for Calculation: The 50% of the last pay drawn or average pay received during the last 10 months, whichever is more beneficial to Judicial Officer shall be taken for the computation of pension.
- (4) Gratuity :- The ceiling limit of Gratuity shall be Rs.10 Lakhs.

Part-II:- REVISION of PENSION IN RESPECT OF THE JUDICIAL OFFICER WHO RETIRED prior to 01.01.2006.

PAY: The revised pension_of a retired_Judicial Officer of Subordinate Judiciary shall be 50% of the minimum pay of the revised pay scale of the post held by him/her at the time of retirement, as revised from time to time.

Explanation: "*Revised pay of the post held*" means Revised scale of pay as define in The Gujarat Subordinate Judicial services(Revision of Pay) rules-2009. and as stated in the schedule 'A' of the said rules.

Part-III:- REVISION of PENSION IN RESPECT OF ALL RETIRED JUDICIAL OFFICER .

- (1) Pension Limit: There shall not be any ceiling limit on the maximum pension payable.
- (2) Neutralization: The pensioners shall be given the benefit of full neutralization of the cost of living in the same scale as is being extended to the serving judicial officers.

Part-IV:- Medical Facilities.

- (1) All the medical facilities available to serving judicial officer with regard to treatment and reimbursement of expenditure etc. be made applicable to retirees.
- (2) In addition to above (1) a retiree judicial officer shall be given Rs. 1500/- per month medical allowances.
- (3) Family pensioners shall be given Rs. 750/- per month as medical allowances.

Part-V :- Domestic Help Allowance.

- (1) A retired Judicial Officer shall be given cash payment of Rs. 2500/- per month as domestic help allowance to retired judicial officers.
- (2) Family pensioners shall be given cash payment of Rs. 1000/- per month as domestic help allowance.

Part-VI :- Additional quantum of pension.

The quantum of pension available to old pensioners shall be increased as follows:-

Age of pensioner/family pensioner	Additional quantum of pension	
From 80 years to less than 85 years	20 % of revised basic pension/family pension	
From 85 years to less than 90 years	30 % of revised basic pension/family pension	
From 90 years to less than 95 years	40 % of revised basic pension/family pension	
From 95 years to less than 100 years	50 % of revised basic pension/family pension	
From 100 years or more	100 % of revised basic pension/family pension	

Part- VII:- FAMILY PENSION

The family pension shall be revised and refixed at 30% of the minimum pay of the pay scale of the post held by the pensioner at the time of retirement..

Explanation: "Revised pay of the post held" means Revised scale of pay as define in The Gujarat Subordinate Judicial services(Revision of Pay) rules-2009. and as stated in the schedule 'A' of the said rules.

All other facilities and amenities/allowances provided to the Government Employees under Gujarat Civil Services (pension) Rules-2002 as amended from time to time which are not inconsistent with the above allowances and amenities OR beneficial shall be provided to judicial officer.

The difference amount of arrears shall be paid in cash in one installment.

In case of any doubt in individual case the pension disbursing authorities and the Directorate of Pension and Provident Fund, Gandhinagar shall refer the matter to the Legal Department, who is the competent authority
