Sub:- Consolidation of 'Interim Allowance'/'Compassionate Allowance' and extension of dearness relief and medical relief on Interim Allowance'/'Compassionate Allowance'

As per existing rule of the Govt of West Bengal no pension is admissible to a retired Govt. employee against whom criminal proceedings involving moral turpitude are pending in a Court of Law. However, in cases of hardship of such employees, an interim allowance not exceeding two-thirds of pension that would have been admissible but for the criminal proceedings is granted during the pendency of such proceedings in terms of Rule 14 of the W.B.S. (D.C.R.B) Rules, 1971. Similarly, under special consideration, Compassionate Allowance not exceeding two-thirds of pension admissible in the case of retirement on medical certificate is granted in terms of Rule 12 ibid, to an official, when he is dismissed or removed from duty for misconduct, insolvency or inefficiency or for conviction on a criminal charge involving moral turpitude.

Govt. of West Bengal, Finance Department, Pension Branch in their Memo No.178(500)-F(Pen) dated 9/4/2012 have since clarified that 'Interim Allowance'/ Compassionate Allowance shall be revised/consolidated as per general orders of revision of pension issued from time to time by the Govt. consequent upon revision of pay & allowances under different ROPAs.

As such, Interim Allowance/Compassionate Allowance sanctioned prior to 1/1/90,1/1/96 and 1/1/2006 shall be revised/consolidated in terms of Govt. of West Bengal, Finance Department's Memo No. 7532-F dated 6/7/88, Memo No.1128-F(Pen) dated 27/10/98 and Memo No.200-F(Pen) dated 25/2/2009. However, if after consolidation, the amount is arrived at less than the amount of minimum ceiling of pension, prescribed in the orders, the same shall not be stepped up to minimum amount of pension in such cases.

In order to facilitate payment of revised rates of Interim Allowance/Compassionate Allowance to the above category of pensioners, two illustrations showing the mode of consolidation of Interim Allowance / Compassionate Allowance are given below:-

Dearness Relief and Medical Relief at the rates as sanctioned by the Govt. of West Bengal for the regular pensioner will also be admissible on Interim Allowance as well as on Compassionate Allowance.

All Pension Disbursing Officers are, therefore, requested to make necessary arrangements for immediate payment of consolidated amount of Interim Allowance/ Compassionate Allowance alongwith dearness relief and medical relief to the above categories of allowance holders, as mentioned above, after proper adjustments.
