All Pension Disbursing Officers are requested to read the line below Example (B) as follows and act accordingly.

"Consolidated Interim Allowance payable in terms of Memo No.200-F(Pen) dated 25/02/2009 @ ₹1853/-p.m. w.e.f. 1/4/2008. It shall not be stepped up to ₹3300/-p.m."
