Co-ordn./65 Vol. IV/51 Date: 25/05/2012 Noew Subject: - Dearness Relief for the retired State Judicial Officers at the revised rate enhanced from 58% to 65% with effect from 01/01/2012 whose pension has been revised as per recommendation of Padmanabhan Committee. In continuation to this office circular No Pen.Co-ordn./65 Vol.IV/217 dated 25/01/2012, it is stated that the Government of West Bengal Judicial Department under their circular letter No 2640-J dated 25/04/2012 has enhanced the rates of dearness relief from 58% to 65% with effect from 01/01/2012 payable to the retired Judicial Officers/family pensioners (whose pension/family pension has already been revised in terms of G.O. No 7014 – J and G.O No 7012 – J both dated 25/10/2010). Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee. All Pension Disbursing Authorities including Public Sector Banks are requested to make necessary arrangements for payment of dearness relief at the revised rate of 65% with effect from 01/01/2012 to the above mentioned categories of pensioners/family pensioners after making proper adjustment of payment already made.
