In continuation of this Office circular No. Pen.Co-ordn/300//213 dated 12/1/2011 on the subject indicated above it is stated that in terms of the Government of West Bengal, Finance Department, Pension Branch Memo. No.635-F (Pen) dated 14.7.2010 (circulated under this office circular No. Pen.Co-ordn/300//92 dated 9.8.2010) other documents viz., Pan Card and Voter's I.D. Card are acceptable as proof of age of the family pensioners for the purpose of being entitled to additional quantum of family pension in terms of Memo No. 200-F (Pen) dt. 25.02.2009. But in some cases it is seen that only year of birth is available on such documents and it has become difficult for the Pension Disbursing Authorities to ascertain the exact date of birth of the family pensioner for the purpose.

Government of West Bengal, Finance Department, Pension Branch have since clarified (received with the Director of Treasuries & Accounts, West Bengal circular letter No. DT/O/24/M-05(Pt-IV)501(65) dated 2/4/2012) that where only the year of birth is available on record, the 1st day of July of that year will be considered as date of birth of that family pensioner in terms of Rule 9(6) of the WBSR, Part-I.

All Pension Disbursing Officers are, therefore, requested to keep note of the above clarification while making payment of additional quantum of pension to the eligible family pensioners on their attaining the age of 80 years and above.
