Subject:- Non-admissibility of additional quantum of pension on family pension, when a pensioner is in receipt of two pensions- one Service pension and other family pension

As per provision, contained in Govt. of West Bengal, Finance Department Memo no. 200-F(Pen)& Memo No.201-F(Pen) both dated 25/2/2009, additional quantum of pension is allowed to the old pensioner/family pensioner in addition to his/her basic pension/family pension, after attaining the age of 80 years. Now the Government of West Bengal, Finance Department, Pension Branch in their Memo. No. 191-F (Pen) dated 16/4/2012 have clarified that when a State Govt pensioner receives family pension from the State, alongwith his/her own service pension, the additional quantum of pension for attaining the age of 80 years and above will not be admissible on family pension. Additional quantum of pension will be admissible only on service pension in such cases.

All Pension Disbursing Officers are requested to keep in mind the above provision while making payment of additional quantum of pension due to attaining the age of 80 years and above to a West Bengal Govt pensioner, who is in receipt of two pensions- one service pension and other family pension and both sanctioned by the Govt of West Bengal.

The above clarification will also be applicable to the pensioners/family pensioners of Non-Govt Educational Institution as well as to Non-Govt. Colleges drawing pension/family pension under Memo Nos.73-Edn(B) and 74-Edn(B) both dated 19/5/2009(circulated vide Pen.Co-ordn/111/Vol-V/259/Vol-II/81 dated 2/9/2009) and Memo No.s 561-Edn(CS) dated 9//9/2009(circulated vide Pen.Co-ordn/51/Vol-IV/115 dated 4/11/2009) and 622-Edn(CS) dated 12/10/2009 and Memo No.441-Edn(CS)[circulated vide No.Pen.Co-ordn/204/Vol-II/114 dated 4/11/2009] & 442-Edn(CS) both dated 23/7/2009.
